What is the Coordinated Plan?

Metro's 2021-2024 Coordinated Public Transit-Human Service Transportation Plan addresses mobility needs and service gaps in LA County for seniors, persons with disabilities, low-income individuals and veterans by providing a framework of strategies and projects developed through an inclusive stakeholder process.





Included participation from:

- > The target groups mentioned above
- Service agencies, senior/disabled advocacy groups
- > Representatives of public/private/ non-profit transportation agencies



What Does the Coordinated Plan Do?

- Assesses transportation services provided for target groups
- > Considers and evaluates current and future transportation needs
- Develops goals and strategies to address gaps in existing transportation services
- Prioritizes projects and programs that will improve mobility for target population groups
- > Helps Metro identify priorities for investments and helps guide private/public transportation operators in planning their own investment approaches





Prioritization and Implementation

The identified projects and program types were evaluated and ranked based on:

- Priorities identified by services agencies
- Addresses target population mobility needs and service gaps
- > Ease of implementation and feasibility



Implementation from 2016-2019 Plan

- > Provided approximately \$53 million in Section 5310 funds to:
 - > 46 different subrecipient agencies throughout LA County
 - > 84 projects throughout LA County
 - > 1,234 replacement/ expansion accessible vehicles
 - > 32 new/expanded operating projects





- > As a result of these projects, annually:
 - Over 200,000 seniors/ individuals with disabilities are afforded mobility
 - Over 4 million one-way passenger trips are provided
