- 1. Welcome and Self Introductions
- 2. Minutes from the January 27, 2017 meeting were approved. Motion made by Ghislaine Davis and seconded by Bea Virobik. Minutes received and filed.
- 3. Silverado Beach Cities and the City of Redondo Beach Dementia-Friendly City Laurie Glover shared the work of Silverado Beach Cities to assist Redondo Beach in becoming a Dementia Friendly Community (see attached document):
 - Redondo Beach would be the first in the South Bay; working with City Council
 - Some of the plans include:
 - o Planned training (certificate) for first responders, police chief, fire
 - o Business would have a sticker in their window to identify "Dementiafriendly" business
 - Laurie will be working with Chamber of Commerce to help implement and promote
 - Once a month businesses that have become "dementia-friendly" will be recognized at City Council with signed certificate
 - o Online training will be available as well as in-person training
 - Offer train the trainer and incorporate into new hire orientation
 - Silverado's certified training
 - Virtual Dementia Tour go through 5 everyday tasks as person with impairment; offered once a month
 - Hillary Theyer asked if there was a way to provide sensitivity training for library staff, and to offer it independently of Dementia friendly city; perhaps offer Virtual Dementia Tours at libraries
 - Adriana Mendoza asked if this was part of Dementia Friendly America? Requires commitment from municipalities and counties.





- 4. Vision of the South Bay in 2030 and Strategies to Get There Wally Siembab and Mohja Rhodes provided an overview of Land Use and Transportation in the South Bay (see attached document):
 - Research began in 2003 with a study looking at 8 different neighborhoods
 - Neighborhood Oriented Development (NOD), adopted in 2010
 - o Concept:
 - Mobility NEV (neighborhood electric vehicle)
 - Mobility BEV (battery electric vehicle)
 - Land Use Marine Avenue re-development simulation
 - South Bay Sustainability Strategy, adopted in 2010
 - Industrial/manufacturing is on its way out; retail business is next
 - Retail space will be available and will be converted to residential
 - Need network service; high speed broadband
 - Develop Smart City
 - Example of new wave of transportation in Manhattan Beach
 - Downtowner
 - Uses smart phone
 - NEV; currently free rides (but tip the driver)
 - Pilot project trying to extend it
 - City of Manhattan Beach stores NEVs in parking garage
 - Funded by advertising on vans
 - o Will invite Downtowner to come to a future meeting
 - Neighborhood Center at major intersections
 - Reorganize current density
 - **Mobility Issues**
 - o Electrify all passenger vehicles
 - o LUVs (local use vehicles) are key
 - Slow speed network
 - o Impact on older adults
 - Potential to continue driving
 - Safer from accidents
 - Ouestions:
