- 3. PATH Homeless Update Lao Moua provided an update and report:
  - LAHSA winter shelters are now open, with exception of SPA 8 (South Bay)
    - Assistance may be available to get South Bay people to drop off centers in other SPAs
  - Homeless Resource Conference was held in October (10/11/17)
    - Designed for homeless leadership
    - Needs to be offered more often in SPA 8
    - 147 registered, although there were more in attendance
    - Lao will share feedback from conference at an upcoming Senior Services Working Group meeting
  - PATH is putting together training videos that will be available throughout SPA8
    - Lao will provide an update as this project progresses
  - Question from Cindy Snodgrass, Torrance: will Hep A vaccines be available at winter shelters?
    - Lao will take idea to Harbor Interfaith

- 4. Los Angeles County New Freedom Programs: Volunteer Driver Mileage Reimbursement Program and Taxicab Services Program – Nicole Persky provided an update
  - Volunteer Driver Mileage Reimbursement Program
    - fully subscribed (250 participants) as of end of November
    - interested people will go on waiting list
    - presentations about program given at Hawthorne and Torrance Senior Centers
  - Taxicab Services Program
    - Active as pf 12/1/17; already 3 participants
    - Participant receives 4 one-way vouchers each month (total of 40 miles per month)
    - Contract with taxi company
    - Electronic card with participant information
    - Taxicab drivers will assist participants, if necessary
- 5. Update on Measure M Guidelines Steve Lantz and Jacki Bacharach provided an update
  - Brief review of Measure R
    - Addresses vehicle delay
    - Big regional projects
    - Will implement 3-4 sub-regional (Caltrans) capital projects
    - Requirement projects must be within 1 mile from major highway
    - Local return money
  - Measure M
    - Extension/supplement to current highway projects under Measure R
    - Includes more than vehicle delay
    - Mobility and sustainability programs, i.e. active transportation
    - Administrative guidelines expected to be approved by Metro in January 2018
    - SBCCOG offering a 90-minute workshop in March 2018

- Money expected to be available starting in July or August 2018
- Municipal operators will receive more money
- What projects would benefit older adults in our communities?
- Microtransit is Metro's version of Uber/Lyft
  - Use Metro's employees to drive
  - o Route deviation
  - o Come to door to pick up rider
- Metro completed slow speed network study of South Bay
  - Need to focus on short trips
  - o Slow speed vehicles up to 25 mph
  - Want to make South Bay a pilot for slow speed projects
  - Comment from Hillary Thayer, City of Torrance Library: If develop slow speed street(s), there is a need to improve arterials (i.e. PCH, Crenshaw, Hawthorne) in terms of signal synchronization, pedestrian synchronization, left turns, etc.
  - o Safe Routes to School needs to be integrated
  - Comment from Stephanie Ramirez, AARP: AARP, in conjunction with LADOT, developed a toolkit on Safe Routes for Seniors that was launched by the Dept of Public Health
- 6. Legislative Update Olina Wibroe from Senator Ben Allen's office provided a brief update on Senator Allen's activities
  - Holiday Meet and Greet with Blue Star Mothers; collected 600 toys for military families
  - Bring any "senior" issues to Olina
