South Bay Cities Council of Governments Infrastructure Working Group July 25, 2012 – Meeting Notes

Chair Beste called IWG meeting to order at 12:07 pm.

- I. **Self-Introductions and Approval of Minutes** Minutes were approved as presented.
- II. PUC Regulations on Street Lighting Update- Chair Beste distributed the Coalition for Affordable Street Lights' (CASL) Settlement Achievements, which reflects their efforts against Edison. He also distributed a *California Current* article, which described the street light rate realignment and the success of the coalition. City Managers have received these documents as well. Chair Beste reported that the rate case is being negotiated by Moreno Valley on behalf of numerous disgruntled cities. The coalition got the rate decreased. SCE will have to keep books regarding street light data from now on, and produce an annual report. City funds no longer subsidize developer projects. If cities want to acquire the rest of their street lights, acquisitions of existing infrastructure will be available for the next several years. SCE has to cooperate. Aaron Klemm, Energy Project Manager for the City of Huntington Beach and coalition member, will present on this at next month's IWG meeting. The South Bay has to stay on top of every rate case. The case was in settlement up until this point, which is why Chair Beste was unable to report until now.

III. Agencies & Other Reports:

- SBCCOG Program update Steve Lantz announced that the SBCCOG invited Metro's ExpressLanes van that sells the new transponders which will soon be required on certain I-110 and I-10 segments as part of its HOT lane pilot program. The van will be selling transponders at the SBCCOG office at 5 pm, an hour before the SBCCOG Board meeting. AAA members can receive a discount by ordering online at the AAA website. Vanpools and carpools will still need transponders. The transponders have the ability to switch from 1-3 drivers which allows single occupant vehicles to be charged for use of the lane and 2 or more occupants to use the lane free of charge.
- SOUTH BAY TRAFFIC FORUM, LA County Dept. of PW Status Paul Choy distributed the South Bay Traffic Forum Status Report for July 2012, which listed the TSSP and ITS projects that Jane White's group is working on. Alan Clelland of Iteris, a firm contracted to develop an Implementation Plan and provide Program/Project Management for the South Bay Measure R Highway Program, used this opportunity to explain the communication opportunity available for transportation agencies to provide traveler information via the city's community access TV channels. He explained that real time traffic reports can be accurately displayed on local cable stations, but only 3 of the 15 South Bay cities are taking advantage of this service that the County provides. Mr. Clelland offered to help cities move forward with this, as it is in Iteris' contract. The data is on arterial congestion and delay cannot be found online. It's a collaboration of agency and private data suppliers, along with Metro and Caltrans. Mr. Clelland encouraged cities to at least put this information online if they lack a cable station.
- Metro PMIS Update, Board Update Fulgene Asuncion announced that Metro's new PMIS database is finally
 completed and is being put into place by Metro's IT Department. Between now and August 20, there will be a
 compilation of existing agreements into the new system. On September 5, the SBCCOG will receive PMIS training,
 and on September 10 lead agencies will receive training. Details coming soon.
- Metro TAC & Streets and Freeway Subcommittee Update Chair Beste had nothing to report.

IV. South Bay Measure R Updates

- **Draft Summary of Early Action projects change requests and new projects-** Steve Lantz encouraged cities to submit any and all status reports in before it's too late. They were due in April but the SBCCOG, Iteris, and Metro are still willing to meet with cities individually to discuss existing and new projects.
- Measure R Extension Potential Ballot Measure Update- Mike Bohlke was not sure of the status of this measure in

the Legislature. He said that the Fasana Motion will probably be approved by Metro on August 6, and will then go before voters in November. He clarified that Metro is seeking a 30 year, not indefinite, extension and that the Fasana motion would eliminate the current restriction to funding transit projects with Subfund highway dollars. The current measure restricts the swaps to once per decade with the first opportunity in 2019.

- SBCCOG concurrence on scope, schedule & budget for Funding Agreements- Steve Lantz remarked that this is a
 good cross-checking process. If a lead agency/city is negotiating a Funding Agreement, they need to make sure it's
 consistent with the original project funds committed.
- V. Measure R SBHP ITS Plan & Strategic Transportation Element updates (Attachment C) Alan Clelland gave a brief overview of two presentations that were given at a recent workshop at the SBCCOG office. Specifically, he spoke about the South Bay Strategic Transportation Element a highway project evaluation tool and South Bay network monitoring program. The project will require a Highway Project Detection Plan and proposed monitoring network. Cities need to identify potential corridors, their technology approach, and develop implementation prioritization. He requested cities' comments as soon as possible.
- VI. Measure R Project Spotlight Hawthorne Rosecrans Ave. Project (F11) –Steve Lantz showed before and after pictures of this completed Measure R project. He reported that when he went in search of the construction sign (before this project was completed), he did not see the SBCCOG logo at the project site. He kindly reminded city staff to post the proper signage agreed upon in Funding Agreements with Metro, and to also invite the SBCCOG to ribbon-cutting and ground-breaking ceremonies.

VII. Other Business-

- 2013 IWG meeting calendar (Attachment D in July IWG packet) and menu change were announced. Next year, no ice cream, no price increase.
- Chair Beste reminded everyone that MS4 permit comments are due as soon as possible.
- Chair Beste reminded everyone that the IRWIMP database is being updated, and that projects will soon be considered for funding. Be ready with your applications!
- Ken Berkman of Psomas announced that he is now an American Council of Engineering Companies CA Los Angeles
 County Member and said he'd be happy to consider capital project nominations for the Engineering Achievement
 Award.
- At the August IWG meeting, Hector Bordas with the Public Works Dept at LA County will discuss the Board of Supervisors' approval of a recommendation to proceed with a protest vote/ hearing regarding the County's Water Quality Funding Initiative.
- Craig Bilezerian of Torrance reported on the Del Amo Blvd. Extension Construction Project and announced that the ribbon-cutting ceremony will occur on August 22 at 4:30 pm. Del Amo Boulevard is located in the central portion of the City of Torrance. The limits of the proposed project are between Crenshaw Boulevard and Madrona Avenue/Prairie Avenue. The project site is currently a vacant right-of-way, surrounded by industrial and manufacturing uses, including the Exxon-Mobil refinery to the north and Dow Chemical to the south. The proposed project would complete the missing segment of Del Amo Boulevard between Crenshaw Boulevard and Maple Avenue and it would widen the existing segment of Del Amo Boulevard between Maple Avenue and Prairie Avenue. When constructed, Del Amo Boulevard will be a four-lane divided roadway within the project limits and provide an additional east-west route throughout the City. Construction also includes a new bridge over the Burlington Northern Santa Fe railroad tracks, drainage improvements and relocation of existing utilities. The City of Torrance certified the final Environmental Impact Report/Environmental Assessment EIR/EA in April 2004. The project's design plans were completed in December 2008. The project will be constructed in 2 phases. Phase 1 will provide for the rerouting of two water pipelines and 2 sewer pipelines. Phase 1 construction was completed in December, 2010. Phase 2 will construct the new 4-lane divided roadway, bridge over the Burlington Northern Santa Fe railroad tracks, and other elements of the project. Construction of Phase 2 will be funded by \$7M from the federal Regional Surface Transportation Program (RSTP); \$3.1M from the American Recovery and Reinvestment Act of 2009 (Economic Stimulus funds); approximately \$6.7M of grant funding from METRO; \$2.6M from Proposition 1B and \$1M from Proposition C. Construction began on November, 2010, and will be ongoing for two (2) years. There is a Facebook page for this project, which can be found at:



SUBJECT: SBHP Matching Funds for Metro Call for Projects (CFP)

BACKGROUND

Metro is responsible for allocating discretionary federal, state and local transportation funds to improve all modes of surface transportation. Metro also prepares the Los Angeles County Transportation Improvement Program (TIP). A key component of the TIP is the Call for Projects (CFP) program, a competitive process that distributes discretionary capital transportation funds to regionally significant projects. Every other year, Metro accepts CFP applications in the following eight modal categories:

- Regional Surface Transportation Improvements (RSTI)
- Goods Movement
- Signal Synchronization & Bus Speed Improvements
- Transportation Demand Management
- Bikeway Improvements
- Pedestrian Improvements
- Transit Capital
- Transportation Enhancement Activities

The 2013 Call for Projects Application will be available in October 2012. Applications are due on January 18th, 2013 at 3 pm. The 2013 CFP is expected to be adopted by the Metro Board on September 26th, 2013. Funds are expected to be programmed for projects beginning in fiscal year 2017-18 and 2018-19. Project sponsors are required to execute a funding agreement during the first year that funds are available and prior to starting any work on the project.

In developing the initial SBHP Implementation, the SBCCOG recognized that the South Bay Measure R dedicated highway funding available over the next thirty years could only provide approximately half of the funding necessary to deliver the identified candidate projects. The Plan recognized that additional sources of funding would be needed. Despite the long-term need to identify additional outside sources, the SBCCOG approved an initial five year list of Early Action projects that are being funded exclusively by the South Bay Measure R Highway funds. These projects are to be completed by fiscal year 2015- 2016.

Each of the Call categories has a required "local match" that must be committed by the lead agency in its project application; the required local match differs for each CFP modal category. For example, in the RSTI category, Metro provides up to 65% of the project cost and the minimum local match is 35%. The relatively low match required in the CFP provides an attractive additional funding source for South Bay Measure R projects. In addition, extra

evaluation points are awarded for lead agencies that commit more than the minimum match. In past Calls, Measure R Subfunds (Subfunds), such as the South Bay Highway Program funding, were not an eligible "local match" source. However, the Metro Board modified its Call for Projects matching policy earlier this year to allow Measure R Subfunds to be considered a "local" match source with a specific limitation that prevents Subfunds from providing more than the minimum required match. As a result, projects for which Subfunds would be the only local match source are not eligible for additional evaluation points since Subfunds are not allowed to be used to overmatch the minimum required match.

Absent additional limitations from Metro, the SBCCOG has a fairly wide range of policy options for determining the equitable shares of Subfund / Local / Metro matching funds.

At the high end, the Subfund could provide 100% of the required local match (e.g. for an RSTI project: 35% Subfund match / 0% Local match / 65% Metro match). However, projects would not be eligible to earn extra points for overmatching the Metro minimum.

At the low end, lead agencies would be challenged to provide the required local match, let alone an overmatch, and would not be incentivized with Subfund local match funds to apply in the competitive CFP process (e.g. for RSTI project: 35% Local match / 0% Subfund match / 65% Metro match.

The middle-ground policy would be for Subfunds to match the lead agency's local funds dollar-for-dollar of the total local match the lead agency proposes in their CFP application. For an RSTI project that is not overmatched: 17.5% Subfund match / 17.5% Local agency match / 65% Metro match).

As an incentive for the project sponsor to gain the points from overmatching, the SBCCOG could increase the share of Subfund in the baseline match. For an RSTI project with a 10% local overmatch, the equitable relevant shares could be 22.5% Subfund match /12.5% Local match / 10% Local overmatch / 55% Metro match. In the application the project sponsor would show the local match and the local overmatch on separate lines to make it clear the Subfund was not providing any of the overmatch.

Since the SBCCOG would only be able to use Subfunds for CFP projects that meet the Measure R Subfund nexus requirements, this policy needs to be determined by the SBCCOG Board by the end of September so that Measure R nexus analysis can be completed, South Bay CFP project applications can be developed, the SBCCOG Board can approve the projects using the SB Subfund match at its November meeting and the applications can be submitted to Metro in compliance with the expected January 18, 2013 deadline.

RECOMMENDATION

The IWG recommends that the Measure R Oversight Committee recommend a dollar-for-dollar matching policy to the SBCCOG Board for use of South Bay Measure R Subfunds as a source of local match in the 2013 CFP applications that meet the eligibility requirements of the CFP and the SBHP and that the total amount of the matching Subfunds committed to any project does not exceed the minimum required local match for the selected CFP modal category.

Please be advised that incorrect information was sent to you on August 13. The FREE upcoming PMIS training that Metro will be teaching is the course that the Metro is making mandatory for cities with Measure R projects. Details on the PMIS training will be sent out when we know the dates and locations of the training session (look for the flyer soon to be released).

The 5-session course on Project Management described below is <u>not mandatory</u>, is open to all members of the South Bay Cities Council of Governments, and costs \$100 per enrollee. Since distributing the Course description and registration form, we have had to answer a few questions, as follows:

If you are still interested in sending a representative from your city to our 5-session course, here are the answers to some Frequently Asked Questions:

- 1. We cannot accept credit cards- only checks. Please let us know if your city cannot cut a check before the deadline of August 31.
- 2. If more than one person from your city wishes to register, the city needs to designate the order in which registrants from the city should be enrolled. We have to wait until each South Bay city has reserved one space before we can allow multiple enrollees from any one city. I will keep you posted as to the space availability.
- 3. We can accept one check for all of the city participants @ \$100 per enrollee.
- 4. If a paid participant can't attend one of the course sessions, another person may not attend in that participant's place.
- 5. There is no refund if a participant cannot attend any of the sessions.
- 6. If your city has multiple Measure R projects, you may charge your full check amount to just one of the projects; there is no need to split the cost between the projects.

Review the different approaches to project delivery including design-bid-build, design/build, CM/GC, CM-at-Risk and Public-Private Partnerships.

Review the different approaches to contract procurement including professional services and construction contracts. Applicable Federal, State and local acquisition regulations will be discussed. Transportation is Gary's specific area of practice as he strives to help address the associated safety, congestion, energy and environmental challenges of our current dependence on the automobile. He has worked on major projects around the world including the Los Angeles Metro, the San Francisco Presidio Parkway, the Seoul Metropolitan Subway in South Korea, the East Side Access in New York and the Cooper River Bridge in Charleston, South Carolina.

Specifically in Southern California, Gary has worked on the San Diego Jackson Street Grade Separation Project, the Long Beach to Los Angeles Light Rail Line (Blue Line), the LACMTA Westside Extension Project (Peer Review), the Measure R Strategic Advisor Report to the Metro Board and the SR 125 Toll Road Project in San Diego County. As President of the Infrastructure Company, Gary was involved in the oversight of all of the firm's projects.

Gary is also a Consulting Professor in the Construction Program at Stanford University. He has taught at Stanford the last three academic years.
