The inclusion of this group can be as simple as allotting some time on an appropriate agenda on a quarterly basis, and would be helpful to some of the other South Bay cities who are also currently embarking on bicycle plans and projects (such as Carson and Hawthorne). The South Bay Bicycle Coalition or one of the representing cities may be able to provide a volunteer minutes secretary.
 - Public Works Commissioner Julian Katz of Hermosa Beach has been in conversations with the seven cities regarding this idea. I am copying him here. He will likely be the appropriate contact going forward. It would be fantastic to have the COG's support in keeping this a regionally comprehensive and connected plan and would nicely compliment the COG's transportation focus. As the region becomes more bicycle-focused, a bike component in the COG's repertoire would aide in grant competitiveness.

Subject: SBCCOG Office Space/Relocation Status Update

Over the past month staff has been coordinating the office move to the new location at the Maritz building in Torrance. Time is of the essence as the current lease ends on Feb. 28, 2012. As directed by Steering Committee, several tasks have been completed and decisions finalized. The following is a summary of progress made since the January Steering Committee meeting:

- **Sublease** signed by both parties and will commence on Thursday, February 16 to coincide with the date tenant improvements are complete for the main office space. Tenant improvements included: painting, moving of furniture, cabling, carpeting, etc. It is anticipated that the large conference room will be completed Wednesday, February 15.
- Phone system, internet, equipment, and relocation it was determined that the current phone and internet system could not meet the growing needs of the staff and future service delivery to cities and general public. For example: the current phone system has a capacity for 16 units and the SBESC has grown to need 19 units. In addition, the current internet system is slow and there is a need for a wider bandwidth which will increase speed, productivity, and our ability to provide technical support to our committees and working groups such as GIS. With input from city experts and Maritz facility management, staff evaluated phone systems and internet technologies, equipment requirements and relocation services and compared providers. Steve Diels was extremely helpful in answering our numerous questions.
- After obtaining 2 quotes to expand current system and 10 vendors re: hosted VoIP, staff selected Hosted VoIP technology to provide phone and internet service. This system includes 19 units, unlimited expansion capabilities, 3M bandwidth, and expanded service package (voice mail to e-mail, individual phone numbers, messaging, Outlook integration, etc.). In addition, the SBESC will be able to keep the current phone number as the main call in line. It is staff understanding that Hosted VoIP is the way phone technology is moving towards for the future. The monthly service fee quotes for this technology ranged from \$1,035 to \$1,237 which is approximately \$470 more than the current service. (Note: the current cost of \$470 would also have increased by about \$80 to accommodate current need.) Equipment purchase cost for this capability ranged from \$3,594 \$5,000. The company selected was 8x8, Inc. and TelePacific at cost of \$3,594.34 for equipment and \$1,035 service. These two firms were selected based on best price and value for service package and system capability with new building.
- Cabling -- WP Electric & Communications was selected at a cost of \$,3599.49. 3 quotes were obtained and ranged from \$3599.49 to \$4496.44 plus tax. WP was selected based

- on lowest cost and guarantee that work would be completed by February 14. In addition, this firm was referred by Maritz and does work with Mar Ventures the property owner.
- Carpet -- will be installed in the two conference rooms and was selected to match the existing carpet in the main office. This cost was included in tenant improvements budget and is no additional cost to the SBCCOG.
- Movers In progress. Update provided at meeting time.
- Schedule -- the move is on schedule and will be completed by Feb. 21st. It is anticipated that on Thursday, February 16 the movers will start after office hours and all furniture and boxes will be moved to the new location. On Friday, February 17, the office will be closed while the phone system transition takes place. During this time, outside calls will be routed to a cell phone. Monday, February 20 the office is closed for President's Day and on Tuesday, February 21 the office will reopen at the new location.

RE: SBCCOG Transportation Update – January 2012

Federal Update:

Congress Resumes Effort To Pass A Federal Transportation Reauthorization Bill by March 2012

Lawmakers in the House and Senate have resumed deliberating on bills to replace the current surface transportation law, the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), which expired more than two years ago and has been extended repeatedly. The current extension is set to expire March 31, 2012.

The Senate Environment and Public Works committee passed MAP 21, its version of a two-year highway bill, in early November. The Senate Commerce Committee passed its version of the bill (S1950) on December 14th that added a federal coordinated freight and port policy to the overall transportation bill and would require that people convicted of drunken driving use ignition interlock devices for a year.

The House of Representatives introduced its transportation reauthorization legislation, the "American Energy and Infrastructure Jobs Act", (HR 7) on January 31, 2012. The bill calls for \$260 billion in spending on transportation infrastructure over five years which is slightly lower annual spending than is proposed in the Senate bill. The House bill would shift more decision-making authority to the states and would expedite the project environmental and approval processes. It also would encourage private-sector participation in financing infrastructure through state infrastructure banks, and expand the highway system with toll roads. The bill also doesn't address high-speed rail, which President Barack Obama supports and Republicans have ridiculed as a costly boondoggle.

If a conferenced bill does not emerge by the end of March 2012, legislators could pass an extension of the current SAFETEA-LU until March 2013.

FTA Approves Crenshaw-LAX Light Rail Project

The Federal Transit Administration issued its final approval on December 30, 2011 of plans for a \$1.72 billion transit line along Crenshaw Boulevard, running from the Green Line near Los Angeles International Airport to the Expo Line. The ruling declares Metro's environmental impact report for the project officially in compliance with the National Environmental Policy Act. It also makes the project eligible for federal funding. The FTA's Record of Decision gives the Los Angeles County Metropolitan Transportation Authority the green light to acquire property, purchase rail cars and move utilities to build the light rail.

In anticipation of the approval, Metro in December issued a request for qualifications from companies that can engineer, design and build the project.

US DOT Starts Application Process For Fourth Round of TIGER Grants

U.S. Transportation Secretary Ray LaHood announced on January 31st the availability of \$500 million in federal funding for transportation projects under a fourth round TIGER (Transportation Investment Generating Economic Recovery) Discretionary Grant program. TIGER 2012 grants are for surface transportation infrastructure capital investments for projects that have a significant impact on the nation, a metropolitan area, or region. Like the first three rounds, TIGER 2012 grants are to be awarded on a competitive basis.

Projects will be evaluated on primary criteria that include safety, economic competitiveness, livability, environmental sustainability, state of repair and short-term job creation. Preapplications are due February 20 and applications are due March 19.

Sacramento Update:

Governor Brown's Budget Proposes to Split Up Business, Transportation and Housing Agency Governor Jerry Brown proposed a major reorganization of state government as an element of his proposed state budget on January 5th. If enacted, the Business, Transportation and Housing Agency would be split, as follows:

- All housing functions, as well as business regulation functions, would be merged with the current State and Consumer Services Agency to create a new Business and Consumer Services Agency. Within this new agency, the California Housing Finance Agency would be merged into the Department of Housing & Community Development.
- Economic development functions, such as the California Infrastructure Bank, would be moved to the Governor's Office of Economic Development.
- Transportation functions would be consolidated under the Transportation Agency.
 These functions include Caltrans, the California Transportation Commission, and the California High-Speed Rail Authority.

CALTRANS Offers Transportation Planning Grants for FY 2012-13

On January 5th, Caltrans announced the availability of grant applications for transportation planning grants that are intended to promote strong and healthy communities, economic growth, and protection of our environment. They support closer placement of jobs and housing, efficient movement of goods, community involvement in planning, safe and convenient pedestrian and bicycle mobility and access, smart or strategic land use, and

commute alternatives. The final results of these grants should lead to the adoption, initiation, and programming of transportation improvement projects that improve mobility, access, and economic vitality.

Caltrans is inviting potentially interested applicants, such as, MPO's, RTPA's, Cities, Counties, Transit Agencies, University/Colleges, Special Interest Groups, and the Public, to apply for the following Transportation Planning Grants for the Fiscal Year 2012-2013:

- Community-Based Transportation Planning (\$3 million)
- Environmental Justice Context Sensitive Planning (\$3 million)
- Partnership Planning (\$1.2 million)
- Rural or Small Urban Transit Planning Studies (\$1 million) Student Internship Development (\$300,000)

Funding for all these grant programs are available on a statewide, competitive basis. Application deadline (to CALTRANS) is Monday, April 2 at 5 p.m.

Grant applications are also available for Transit Planning (FTA Section 5304), Statewide or Urban Transit Planning Studies (\$1.5 million). Deadline (to SCAG) for FHWA/FTA 5304 grants is Feb. 17 at 4 p.m.

Assemblyman Feuer Introduces Two Rail Project Acceleration Bills

Feuer's first bill, A.B. 1446, would allow L.A. County voters to vote on a ten-year-or-more extension to the Measure R transit tax which is slated to expire in 27 years. This extension would enable Metro to bond against future Measure R revenues and build those transit projects much earlier than originally contemplated, without relying on federal or state funding. A two-thirds support vote in L. A. County would be needed to pass the tax extension.

Feuer's second piece of legislation, A.B. 1444, would apply the benefit from Governor Brown's legislation that allows for expedited legal challenges to environmental reviews for large projects to transit projects as well. The bill would maintain CEQA's project mitigation and public review requirements while reducing the timeline for judicial review, thus allowing more environmentally friendly projects to be built more quickly.

New State Laws Traffic-related Effective January 1, 2012

Young passengers age seven and below are now required to ride in a booster seat in any vehicle, unless they are at least 4-feet-9-inches tall. Previously, only child passengers who were up to age six or weighing less than 60 pounds were required to ride in a car seat or booster seat. The fine and penalty assessments will push the cost of the ticket to \$446 for a first offense or over \$1,000 for a second offense.

Under AB 520, a person convicted of alcohol-related reckless driving will be eligible to apply for a restricted license after three months, instead of a year as previously allowed, provided they comply with specific requirements such as installing an ignition-interlock device.

Assembly Bill 353 prohibits law enforcement from impounding a vehicle at a sobriety checkpoint if the driver's only offense is not having a valid driver's license. Police must also make a reasonable attempt to identify the registered owner of the vehicle in order to release the vehicle to the registered owner or to a licensed driver authorized by the registered owner.

SB 857 allows traffic violators a 50 percent discount on unpaid traffic fines; the discount is being offered through June 30, 2012. Motorists who have unpaid traffic fines can send in just half of what they owe and clear the slate. Some restrictions apply, including that the violator cannot have any outstanding misdemeanor or felony warrants. Another restriction leaves out anyone who has tried to pay off part of the fine.

As of July 1, under AB 1215, new-car dealers are required to electronically register a new vehicle with the DMV when it is sold, and the law allows dealers to charge up to \$80 for electronic document processing and up to \$65 for manual processing. The law also requires used-car dealers to provide vehicle buyers with a vehicle history report from the National Motor Vehicle Title Information Service before they purchase the car, and prohibits the dealer from selling the car without obtaining the report. Sales of motorcycles, off-road vehicles and recreational vehicles are exempt.

As of July 1, state vehicle registration fees will rise by \$12 from \$31 to \$43 per year, which will be used to fund DMV operations. This fee is charged along with the Vehicle License Fee, which is based on the vehicle's assessed value, and various other local and state fees.

Southern California Update:

Metro To Hold Public Hearings on Proposed Service Changes

METRO will hold public hearings in February 2012 to receive community input on proposed modifications to Metro's bus service. Approved changes will become effective June 17, 2012 or later. Proposed changes in the South Bay include:

- Line 40 (Downtown LA-South Bay Galleria via M L King-Hawthorne) Reduce frequency and assign larger articulated vehicles to maintain seat capacity.
- Line 607 (Windsor Hills Inglewood Shuttle) Modify route to serve Ladera Center at La Tijera Bl. and Centinela Av.
- Line 710 (Wilshire Center South Bay Galleria via Crenshaw Bl.) Assign smaller 40 foot vehicles and increase frequency to maintain seat capacity.
- **740** (Crenshaw Station South Bay Galleria via Hawthorne Bl.) Assign smaller 40 foot vehicles and increase frequency to maintain seat capacity.

The South Bay public hearing will be held during the Metro South Bay Service Council meeting on February 10, 2012, 9:30 am, Inglewood City Hall, One Manchester Bl., Inglewood, CA. 90301 Written testimony must be postmarked before mid-night February 13, 2012.

Torrance Considers Service Cuts, Fare Hikes To Reduce MAX Subsidies

Torrance faces a March 2 deadline to either withdraw from MAX or confirm its participation for the next fiscal year that begins July 1. Rather than simply eliminating their subsidy, Torrance city officials will consider curtailing routes, raising fares and other options to reduce the city subsidy before deciding whether to pull out of a local government consortium that operates a rush-hour bus line to El Segundo.

The Municipal Area Express provides peak-hour service on three routes which link aerospace employees as well as military personnel who live in San Pedro to their work at El Segundo's Los Angeles Air Force Base. Two lines serving Torrance operate at just 50 percent capacity. The third line runs from the gates of a military housing complex in San Pedro to the Air Force base entrance and is much busier, with some commuters forced to stand for the trip.

Options include raising the \$1.75 fare for the peak hour service and eliminating or curtailing any of the three routes. Elimination of the Torrance subsidy could result in cancellation of the MAX service.

LA County Ordinance Hopes to Create Healthier New Developments

Los Angeles County supervisors approved an ordinance on January 25th that requires new developments in unincorporated areas of the county to have wider sidewalks, bicycle parking and other changes to promote exercise and reduce obesity. The ordinance also would make it easier for communities to start community gardens, hold farmers markets, and increases shade on sidewalks. The supervisors also passed a motion that directs more research and design on making the county friendlier to pedestrians and bicyclists.

METRO To Create Integrated County-Wide Bike Share Program

METRO approved a bike share strategy on January 25th for the agency to create a mechanism for municipalities and cities to work together and create a county-wide bike share plan. Through a bike share program, people can rent bikes at a docking station and ride it to another station located somewhere else. Systems can be publicly or privately owned and sometimes require renters to be members of the bike share program. The cities of Long Beach, Los Angeles and Santa Monica have plans and funds set aside for bike share programs.

SUBJECT: Authorization to Release Results of Metro Congestion Mitigation Fee - South Bay

Pilot Nexus Study Findings

BACKGROUND

Metro has been working with South Bay jurisdictions and the SBCCOG on a Pilot Study to determine the feasibility of implementing a countywide congestion mitigation fee program which would create fees that could be charged to new development for transportation projects in the South Bay sub-regional transportation network. If adopted, the countywide congestion mitigation fee program would provide the methodology for jurisdictions to demonstrate their compliance with the state-mandated Congestion Management Program and to continue to receive their state gas tax revenue.

The fee-based program on new development also would succeed the existing L. A. County Congestion Management Program Countywide Deficiency Plan, which has been suspended for several years as the fee-based program is being developed.

The Preliminary Findings of the South Bay Cities Pilot Study revealed that a reduction in congestion growth of approximately 50% over the next 20 years would be realized from 169 transportation projects submitted by the South Bay jurisdictions at an estimated cost of \$444 million.

Metro has undertaken several sub-regional Congestion Fee Pilot Studies during the last 18 months to gather input from local jurisdictions including: local growth forecasts, identification of the South Bay regional transportation network, a list of local projects and estimated costs that would benefit the regional transportation network.

Metro consultants developed the evaluation methodology and conducted the preliminary statemandated nexus analyses. The South Bay nexus analysis evaluated the aggregate reduction in vehicle-hours-of-delay and the cost-per-trip for each jurisdiction and the South Bay as a whole. The study findings included the minimum cost-per-new-trip that might be charged by jurisdictions in the sub-region to partially fund the transportation projects and the maximum cost-per-new-trip that would be legally allowable if 100% of the transportation project costs in the sub-region were paid from the congestion mitigation fee.

For the South Bay, the minimum cost-per-new-trip could be as low as \$300 and the maximum could be as high as \$1,758. This range could change significantly based on the type of projects selected, their estimated costs, the trips generated by the development, and the total trips reduced by the projects.

A workshop was held with SBCCOG cities and MTA on January 10, 2012 to review the South Bay Cities Pilot Study Preliminary Findings, to receive local feedback and to address questions. Metro emphasized that the mitigation fee would have to be imposed by local jurisdiction(s). Metro would not receive any of the funding; all fee revenues would be collected and expended by the local jurisdictions. Several jurisdictions that currently have a development mitigation fee were assured that the regional fee would not be imposed on top of any local development fee programs that are funding transportation projects on the regional transportation network. In addition, since these are pilot studies, Metro staff emphasized there will be an opportunity for jurisdictions to update their list of projects prior to the formal Congestion Mitigation Fee program development phase.

Metro staff is seeking each COG's permission to share their sub-regional Pilot Study results with other sub-regions and their respective COGs. This action would allow Metro staff to compile the results from all the sub-regions into a countywide report that would be presented in a board report that would seek Metro Board authority to prepare a detailed countywide Congestion Mitigation Fee program.

The SBCCOG has not taken a position on establishing a countywide congestion mitigation fee and taking this action does not constitute an endorsement of the fee program.

RECOMMENDATION

The SBCCOG Steering Committee authorizes Metro staff to share the preliminary findings of the South Bay Cities Pilot Study Preliminary Findings with other COGs and the Metro Board with the commitment that the South Bay list of projects and cost estimates may be updated prior to the preparation of a formal countywide congestion mitigation fee program by Metro.

The SBCCOG is continuing to recruit Rancho Palos Verdes. Rolling Hills has declined participation in the EEMIS program since they only have one small building.

Pre-Launch Data (EEMIS Data Entry Forms):

The SBCCOG is creating an inventory of city owned buildings and their associated utility accounts that will be used as the basis for EEMIS reporting and will facilitate Energy Leader Program targeted audits.
