SUBJECT: Strategic Plan Scope of Work & Release of Request for Proposal

#### Background

At the July Steering Committee, a memo was presented which outlined the following:

- Requirements of the Jacki Bacharach & Associates contract with the SBCCOG for a strategic plan to be completed
- A proposed schedule
- A proposed scope and tasks
- The outline of a proposal
- The adopted Vision, Mission & Guiding Principles

Also in July, 2 of the 4 member City Manager subcommittee met to review the purpose and process for a strategic plan exercise. Their ideas were presented to the Strategic Plan subcommittee when the subcommittee met on July 25. This memo serves to summarize all of these discussions and provide the subcommittee's recommendations for moving forward with a strategic planning exercise.

#### STRATEGIC PLANNING SCOPE - THE WHAT

#### The Subcommittee:

- Reviewed the Mission, Vision, and Guiding Principles which were adopted in June 2012 and there was consensus that they do not need to be re-evaluated and were still accurate and relevant.
- Agreed that a SWOT analysis should be done (strengths, weaknesses, opportunities & threats).
- Agreed that there should be a discussion of how the SBCCOG came to its current work program and where the organization is going a 5-year outlook
- Posed some questions for further facilitator led discussion:
  - How do we identify priorities?
  - Are the SBCCOG's priorities the cities' priorities?
  - Why do SBCCOG members come to the meetings? What are they finding of value?
  - What do the cities want from the SBCCOG?
  - What are the roles and responsibilities of those who serve on the Board and Steering Committee and of the City Managers?
  - What is the SBCCOG's worth to its members?
  - Who are other stakeholders (regional agencies) that find value in the SBCCOG?

#### STRATEGIC PLANNING PROCESS - THE HOW

The Subcommittee also decided that the participants should include all Board members (delegates and alternates), city managers, SBCCOG Committee Chairs (IWG, GIS) and SBCCOG staff.

The format should include interviews by the facilitator in advance with a number of key people, a full-day workshop, a presentation of the findings, and a written summary report. Specifics of this format would be filled in by the selected facilitator consultant.

#### STRATEGIC PLANNING PRODUCT

It was also important to the Subcommittee to have a product that addresses the questions above and initiates focused action with measurable results.

#### **BUDGET**:

\$15,000-\$25,000 which will come from reserves.

#### SOLICITATION:

A list of 27 firms obtained from Hermosa Beach will receive a request for proposal.

#### Proposed Scope for Inclusion in the Request for Proposal

The South Bay Cities Council of Governments (SBCCOG) wishes to clearly define its priorities and value to its members and to establish goals and objectives consistent with its vision, mission and guiding principles adopted June, 2012, in a defined time frame and within the organization's capacity for implementation. It also would like to review the roles and responsibilities of its leadership.

The SBCCOG wishes to utilize the services of a professional facilitator to facilitate its strategic plan and goal setting effort to address the next five years by prioritizing programs and services based on their ability to achieve these goals and to create a document to memorialize this effort.

The SBCCOG invites consultant firms or individuals experienced in strategic plan/goal setting facilitation with elected officials to submit proposals. The SBCCOG is looking for an objective voice, someone who is not likely to have strong predispositions about the organization's strategic issues and ideas in order for the entire membership to benefit. The SBCCOG is ultimately seeking consensus among its elected officials and city managers or senior management within our member jurisdictions.

#### Specific Tasks:

- A. Facilitation of Strategic Planning/Goal Setting and Workshop Process:
  - 1. Preparatory meetings with city managers (at least 3) and SBCCOG senior staff
  - 2. Workshop with the Board of Directors and SBCCOG senior staff
  - 3. Follow-up meetings with the City Managers Committee and Board of Directors to review the results
  - 4. Preparation of final report
- B. Full day Workshop with Board and City Managers (at least 3 not necessarily the same as the interviewees) and SBCCOG senior staff
  - 1. Assessment of the SBCCOG's strengths, weaknesses, opportunities and threats
  - 2. Identify and develop specific short-term and long-term goals and priorities for the SBCCOG and how they add value for the members
  - 3. Review roles and responsibilities of the membership
  - 4. Identify potential fiscal constraints and opportunities in order to achieve strategic goals and objectives
  - 5. Review budget process for potential modifications
- C. It is the desire of the SBCCOG to begin the Strategic Plan/Goal-Setting Facilitation process in no later than November 1, 2013.
- D. Facilitator must summarize the results of the workshop and pre-meetings and prepare a document by January 6, 2014 that summarizes the consensus reached regarding the SBCCOG's strategic goals and objectives for the next 5 years, and priorities and ranking the SBCCOG's programs and services based on their programmatic and financial ability to achieve these goals.

#### Proposal (would include our standard clauses and contract)

**Background** - The South Bay Cities Council of Governments (SBCCOG) is a joint powers authority of 16 cities and the County of Los Angeles that share the goal of maximizing the quality of life and productivity of our area. Within this structure, the cities and the County maintain the qualities and characteristics that make them unique and independent, while collectively addressing issues of common interest for a greater good. This collective vision of what the SBCCOG can do for our communities is what motivates our members and can best be described four ways — *Partnership, Planning, Persuasion, and Performance* 

Overseen by a Board of Directors, the SBCCOG conducts business through committees and working groups made up of city and county elected officials and staff, city and county staff, government partners, and members of the community. These groups focus on issues such as public transportation, energy, sustainability, livable communities, geographic information systems (GIS), legislation, economic development, regional planning, carbon emission reductions, and city infrastructure.

The major programs of the SBCCOG are:

- 1. Operating the South Bay Environmental Services Center
- 2. Facilitating the implementation of the \$906 million South Bay Measure R Highway Program
- 3. Bringing to the members programs and projects addressing sustainability of the region including developing sustainability strategies for transportation and land use including alternative transportation programs such as electric vehicle readiness and climate action planning.
- 4. Monitoring the work of and representing South Bay interests at regional and state agencies

**Qualifications** – The firm or individual responding to this RFP must provide:

- I. Evidence of substantial knowledge and experience in developing strategic plans/goal-setting efforts for local government organizations at the elected official level.
- 2. References including the name and contact information for 3 similar organizations (councils of governments, local governments) where facilitator worked recently in goal setting/strategic planning.
- 3. One copy of a similarly scoped strategic plan developed for one of these elected bodies.

**Costs** – The Board of Directors has allocated \$15-25,000 for this planning process. Please provide 'not to exceed' costs for the following categories:

- 1. Preparatory meetings
- 2. ½ day workshop with the Board
- 3. Full day workshop with the Board

- 4. 1 follow-up meeting with the Board and 1 follow up meeting with the City Managers to review the results
- 5. Preparation of the final report

#### **Federal Update:**

#### **Congressional Transportation Spending Debate Begins for Federal Fiscal Year 2014**

It looks like budget season in Congress is going to be a rocky road due to sequestration and spending cap concerns. After the House Appropriations Committee approved its version of the Transportation, Housing and Appropriations Bill a month ago, House leadership has postponed a floor vote on its bill until September and will consider the measure that was approved by the Appropriations Committee after its August recess. The Senate debated a \$108 billion Senate Transportation Housing and Urban Development Appropriations bill (S. 1243) on the Senate floor during the last week in July hoping to pass the bill before its recess then failed to pass the bill August 1<sup>st</sup> after a Republican filibuster.

The Senate bill would boost Fiscal Year 2014 funding for infrastructure projects and housing subsidies for the poor and is the first bill in a broader budget framework for a number of appropriation bills set up by Senate Democrat leaders that seek to replace deep cuts to agency operating budgets with tax increases and more modest curbs on spending. The measure spends about \$10 billion more than the transportation portion of current House version of the bill. The higher Senate spending levels would permit \$550 million in transportation infrastructure grants first established in the 2009 economic stimulus bill and a new \$500 million fund for "bridge repairs in critical corridors (BRICC)" projects for structures that are seriously deteriorated or "functionally obsolete" – read that as overly congested and in need of widening. The companion House measure contains no infrastructure funding, eliminates high speed rail funds, eliminates Amtrak overtime, and cuts community development block grants to \$1.6 billion, about half the level called for by the Senate.

The dueling Republican and Democratic fiscal philosophy may forebode another series of continuing resolutions. Because the federal fiscal year begins October 1<sup>st</sup>, unless agreement is reached between the House and Senate by September 30<sup>th</sup>, a continuing resolution would be needed to maintain FY14 spending at current levels and to prevent a partial shutdown of the affected federal agencies. However, the continuing resolutions may be difficult since the Senate bill is \$7 billion above the sequestration limits that became law as a consequence of Congress's failure last summer to agree on a broader federal budget.

#### **House Told Highway Trust Fund Is Nearing Empty**

The House Subcommittee on Highways and Transit held a hearing on July 26<sup>th</sup> to shine a spotlight on the dreadful financial status of the Highway Trust Fund. The HTF will be unable to meet its obligations sometime in 2014. Barring additional revenues (e.g., a 10-cents per gallon motor fuel

tax increase or a \$15 billion general fund transfer), DOT will start rationing reimbursement payments to states. Since the Federal Highway Administration (FHWA) reimburses states for their expenditures rather than advancing funds, state departments of transportation enter agreements with FHWA, award contracts to construction companies and then rely on getting payments from the feds in order to make payments to the contractors. If the situation gets bad enough, the feds might only be able to cover a portion of states' reimbursement requests.

Revenue deposited in the HTF comes from federal fuel taxes – 18.4 cents a gallon on gasoline and 24.4 cents a gallon on diesel fuel. The Highway Trust Fund is made up of two accounts -- one for highways and one for transit. As it stands, budget forecasts indicate that by the end of fiscal 2014 the highway account will have a cash balance of \$4.6 billion. That's problematic, because in a given month the feds might reimburse states more than \$5 billion. The transit account faces a similar shortfall as the highway account: It will end the year with a \$300 million balance, but some months, it pays out as much as \$1 billion. To meet its reimbursement obligations to states, Congress has been transferring money to the fund since 2008; Congress has transferred a cumulative \$41 billion from the general fund to the HTF, with another \$12.6 billion set for 2014.

It's not entirely clear how states might respond to the current situation. Kim Cawley, a Congressional Budget Office analyst, testified at the hearing that there are a few possibilities. They might be willing to simply wait longer for their reimbursements; they might slow down projects to avoid overextending themselves; or they might actually speed up construction in an effort to get reimbursed ahead of other states and before the money runs out.

#### Labor Agreement Discord Forces Feds to Freeze California's Transit Funds

The federal government has frozen more than \$1.2 billion in transportation grants to California as it weighs whether the state's recent pension-reform efforts violated the collective bargaining rights of workers. In addition to locking up capital project funding, the freeze has also brought labor negotiations to a standstill as both sides wait for the federal Labor Department to act. The dispute centers on a California law passed last year that put limits on the pensions that public agencies can offer their new hires. Supporters of the law touted it as common-sense reform that would help reign in the huge pension obligations that cities, counties and other government agencies have run up.

But labor unions countered that it violated their collective-bargaining rights by rolling back benefits for future employees without negotiation. The unions invoked a section of federal law that demands a guarantee from any agency receiving federal transit grants — that it will preserve the collective-bargaining rights of its workers.

The Labor Department took up the issue, and has refused to certify California projects as eligible for transit grants that were, for the most part, awarded this year, until it can decide whether the state pension law violates that provision.

#### **Oregon Passes Nation's First Road-Usage Tax**

The Oregon State Legislature on July 7th overwhelmingly passed the first-ever legislation in the United States to establish a road usage charge system for transportation funding based on miles

driven to replace the state gas tax. The bill authorizes the Oregon Department of Transportation (ODOT) to assess a charge of 1.5 cents per mile for up to 5,000 cars and light commercial vehicles and issue an equivalent gas tax refund to users. The bill calls for the system to be operational by July 1, 2015.

Mileage-based user fees (MBUF) — or road usage charges (RUC) — are an alternative way to fund the construction and maintenance of roads. Rather than the current gas tax method, which is based on the amount of fuel purchased at the pump, or toll lanes in which users are charged for use of a specific lane, a vehicle mileage fee or road usage charge is based on how many miles are driven.

#### **Sacramento Update:**

**Legislators Send Governor Bill Banning Cities From Ticketing at Broken Parking Meters** State lawmakers approved AB 61 on July 3<sup>rd</sup> that would prohibit cities across California from ticketing motorists who park at meters reported broken that the city failed to fix. Existing law authorizes parking at an inoperable parking meter for up to the posted time limit if no ordinance or resolution has been adopted to prohibit it.

But existing law also authorizes a local authority to adopt an ordinance or resolution prohibiting or restricting the parking of a vehicle at an inoperable parking meter or inoperable parking payment center, as defined. So, local jurisdictions have adopted ordinances allowing issuance of parking tickets at inoperable parking meters. If Governor Brown signs the legislation, it would take effect January 1, 2014 and will be in effect until January 1, 2017.

On July31<sup>st</sup>, Los Angeles City Council revoked an L. A. City 2010 law allowing parking citations at inoperable meters at least half a year to assess its effect on vandalism of meters by people hoping to avoid paying. Los Angeles City has more than 37,000 digital meters that take credit cards and cash. The city is automatically informed when these machines malfunction.

California Highways Among Worst In Nation; Increased State Gas Tax May Help
The state excise gas tax had not been raised in two decades until Monday July 1<sup>st</sup>, when it was increased by 3.5 cents per gallon. But the 20 year stagnation has resulted in California's highway system being ranked 47<sup>th</sup> among the 50 states in overall highway performance and efficiency in the latest annual highway report by the Reason Foundation. That is a slight improvement for California, which ranked 48<sup>th</sup> in the two previous studies. Only Alaska, Rhode Island and Hawaii have worse roads. The report covers road conditions through 2009, the most recent year data was compiled by the US Department of Transportation.

According to the report, California spent \$679,000 per mile on road maintenance and other highway upgrades in 2009 making per-mile spending in the state nearly five times the national average. But with 18,260 miles, California's highway system is the 11<sup>th</sup> largest in the nation and carries the most traffic of any state. California's urban interstates are the most congested in the nation, ranking 50th. The state ranks next to last in urban interstate pavement condition and 49th in the condition of key rural roads.

The dismal condition of roads is especially critical since new regulations being issued by the federal government to implement MAP-21 may require first use of formula federal gas tax funds to repair federal highways that are not meeting new performance standards.

#### **Southern California Update:**

Ramp Closures Announced for I-405 Northbound Carpool Lane Construction Zone Beginning August 3, 2013, the northbound off-ramp to Sunset Boulevard will close for 120 days for the construction of a longer and wider off-ramp. The new Sunset Bridge configuration will feature two northbound right-turn lanes to eastbound Sunset and one northbound left-turn lane to westbound Sunset The new off-ramp will add 60 percent more capacity to store vehicles and segregate traffic from Sunset Boulevard and the I-405.

On August 22, demolition of the northbound I-405 on-ramp from eastbound Wilshire Boulevard begins, marking the last leg for re-constructing the I-405/Wilshire Boulevard ramps. The Wilshire ramp demolition, expected to last 90 days, will result in a new on-ramp with 280 percent more vehicle storage capacity, created by the bridge's increase from 824 to 3,129 feet in length.

#### LA Mayor Garcetti appoints three new Metro Board Members; Bonin has Triple Play

The mayor of the City of Los Angeles controls four seats on the Metro Board of Directors. On July 18<sup>th</sup>, new Los Angeles Mayor Eric Garcetti named two city councilmen and a nonprofit leader to join him on the board: L. A. City Councilman Paul Krekorian from the San Fernando Valley, Mike Bonin from the Westside, and Jackie Dupont-Walker, president of the USC Master Plan Advisory Committee and president of the Ward Economic Development Corp. Garcetti's appointees replace board members appointed by former mayor Antonio Villaraigosa: Mel Wilson, Richard Katz and current L. A. City Councilman José Huizar.

Councilman Bonin, who replaced former LA City Councilman Bill Rosendahl on July 1<sup>st</sup>, had a triple-play first month as he was appointed Chairman of the LA City Council Transportation Committee and Vice Chair of the Exposition II Construction Authority Board.

#### **Metro Orders 25 All-electric Buses**

Metro has signed a contract with BYD Motors for up to 25 new all-electric buses, as an element of a \$30-million clean air bus technology pilot project. An initial purchase of 5 vehicles provides an opportunity to determine whether electric buses can meet LA's rigorous performance requirements. If those work out, Metro may choose to purchase up to 20 additional buses. Metro is also soliciting bids to covert six of its existing hybrid buses to Super Low Emission Bus standards.

Metro's Super Low/Zero Emission Bus Program started in 2011 to meet future vehicle emission reduction targets set by the California Air Resources Board. The program tests EV technologies to check for improved operating characteristics including more range, better integrated subsystems and lighter weight construction. The overriding question is whether the electric buses reduce operating, maintenance and life cycle costs compared to Metro's current fleet.

#### Metro to Study Conversion of I-405 HOV Lanes to Express Lanes

At the urging of Metro Board Member Mike Antonovich, the Metro Board on July 25th asked Metro staff to produce a report on whether it makes sense for the HOV lanes being constructed on the I-405 to become High Occupancy Toll Lanes to offset the ever expanding budget of the widening project. Metro staff is also exploring creation of HOT Lanes for the I-5 and I-405 from the Orange County line to LAX to pay for expansion of the local HOV network. Metro will report on the performance of the existing I-110 and I-10 Express Lanes in 2014 once the demonstration project period ends

#### **Interim ExpressLane Performance Evaluation Released by Caltrans**

More vehicles traveling at higher speeds are using the high-occupancy vehicle lanes on the 110 Freeway since they were converted to ExpressLanes, while speeds on the other lanes largely remained constant, according to a six-month evaluation of the project by Caltrans. Workweek trips are averaging 57,256 per day on the ExpressLanes compared with the average of 50,000 trips before the 11 miles of ExpressLanes were installed between the 91 Freeway and Adams Boulevard. Ridership on the Metro Silver Line has increased 5 percent, a figure that closely tracks the 4 percent improvement in on-time transit performance. In addition, 18 new van pools have formed.

The average ExpressLanes speed on the Harbor Freeway was 65 mph during the peak morning commute, from 5-9 a.m. The average speed for the rest of the freeway lanes during the peak morning commute was 48.3 mph, largely unchanged from the average speed of 48.4 mph prior to the Nov. 10 opening of the ExpressLanes. Travel speeds have actually exceeded the goal of an average 45 mph speed 90 percent of the time during peak periods. In the morning peak travel period (6-9 a.m.), average speeds in the 110 ExpressLanes have increased by over 5 mph with the implementation of ExpressLanes. The average price for the trip was \$5.35, although the cost during the peak morning commute was considerably higher -- about \$10. However, a majority of trips cost less than \$3 in either direction. About 41 percent of motorists drive solo and pay the fee, while the remainders have 2 or more people in the vehicle.

Metro cautioned that the data is preliminary and subject to change ahead of an independent evaluation scheduled for release in mid-2014.

#### Palos Verdes Peninsula Transit Changes Schedule for August

Now that summer school has ended Palos Verdes Peninsula Transit will only be running buses on the 225/226 lines through the end of August, according to a message sent Friday from the Palos Verdes Peninsula Transit Authority. All other bus lines will begin to run Aug. 27, when school starts.

Line 225 runs all day from Averill and Eighth Street to Palos Verdes Boulevard and Via Valencia, with stops by Miraleste Intermediate School and the Promenade on the Peninsula in between. Line 226 services Palos Verdes Drive West in the mornings and evenings.

Re: Measure R Oversight Committee Roles and Responsibilities

During discussions at the July 8, 2013 Steering Committee, Jim Goodhart requested that staff provide a summary of the tasks and purposes of the Measure R Oversight Committee (MROC).

#### **BACKGROUND**

The Measure R Oversight Committee (MROC) first met on January 18, 2011. The Steering Committee initially chartered the MROC as a Sub Committee when Steering Committee leader recognized that the scope of the Measure R Highway Program (SBHP) was too large and complex to be provided proper consideration during the Steering Committee monthly meetings.

Many of the Steering Committee members have also served on the MROC since its inception. In 2012, recognizing that there was unnecessary duplication in the matters being considered by the MROC and the Steering Committee, the subcommittee became an official committee and most MROC recommendations now go directly to the Board of Directors rather than through the Steering Committee.

MROC voting members are limited to elected officials representing SBCCOG member jurisdictions. The Infrastructure Working Group is the technical advisory committee to the MROC. Other agencies, SBCCOG consultants and staff, private consultants, and interested members of the public are also encouraged to participate in the MROC committee meetings.

The MROC officers are the Chair and Vice Chair. The Chair officiates at MROC meetings and is expected to provide committee reports and present recommendations to the monthly SBCCOG Board. The MROC Chair may also be asked to represent the SBHP and the SBCCOG on policy matters and Board-approved intergovernmental advocacy. Schedule permitting, the Chair is invited to participate in the Infrastructure Working Group meetings and SBHP workshops. The Vice Chair is expected to participate in all MROC meetings and to become conversant with the SBHP, the policies and procedures of the Committee and to chair meetings or provide reports to the SBCCOG Board in the absence of the Chair. Other SBCCOG Board members, alternates and elected officials representing all SBCCOG member jurisdictions are encouraged to participate in the MROC deliberations and advocacy efforts and to consider taking a leadership role in the committee. This participation in the committee is essential as it takes four elected officials to provide a quorum for actions to be taken at the MROC.

#### **PURPOSE**

The purpose of the committee is to provide administrative and policy oversight of the staff and consultants work related to South Bay Highway Program (SBHP) on behalf of the SBCCOG Board of Directors. The MROC recommends policies, procedures and provides SBHP status updates to the SBCCOG Board. The recommendations generally fall into four areas: SBHP program development, SBHP project oversight, SBHP-related intergovernmental relations between the SBCCOG, its member jurisdictions, lead agencies for SBHP projects, and Metro; and SBHP-related administration.

MROC meeting agendas generally includes the following tasks:

- Metro and Caltrans Updates monthly
- SBHP Project Status Updates (Monthly Project Progress and Project Risk Reports)
- 3-month Look Ahead Summary and SBHP Implementation Calendar Update monthly
- SBHP Project Spotlight monthly
- Metro Contract Status Report with Contract Remaining Funds Report quarterly
- Metro Budget Request annually in November
- SBHP Implementation Plan Updates biennial small update and large revision
- Workshop announcements / SBHP training opportunity notices as needed
- Program development, project oversight, intergovernmental relations, administrative and policy development recommendations to the SBCCOG Board as needed

The SBCCOG Board adopted a SBHP Delegation of Authority Policy on September 28, 2012. Under the policy, the following SBHP actions require approval by the **Metro Board**:

- New SBHP project eligibility within Measure R Ordinance, Expenditure Plan and other Metro Board Guidelines and policies (e.g.: Call for Projects local match)
- Measure R Expenditure Plan that identifies the annual South Bay Subfund revenues available for SBHP program
- Programming of SBHP projects in the SCAG RTP, Metro LRTP and SCAG TIP
- Measure R South Bay Subfunds eligible to be committed as local match for Metro Call for Project Applications
- Annual Measure R SBHP project list, annual contingency funds, program administration funds, inter-agency coordination funds, program development funds and project oversight funds
- Swaps of Measure R Subfunds between highway and transit projects (2/3rds Metro Board vote required)

The following SBHP actions require approval by the **SBCCOG Board**:

- SBHP recommended project funding allocations
- Annual Measure R SBHP project list update
- Bi-annual South Bay Highway Program Implementation Plan Update including policies, procedures and process changes
- Measure R South Bay Subfunds recommended to Metro for Metro Call for Projects South Bay Project Applications
- Annual Measure R South Bay Subfund budget request to Metro
- New SBHP Contracts and Task Orders in excess of \$50,000
- No-net-change reallocations of contract or task order scopes and funding in excess of \$50,000

- Any reallocations or contract or task order scopes and funding that are outside of the adopted budget or implementation plan no matter what the value
- Changes required to the South Bay Implementation Plan that are time critical and cannot wait until the regular bi-annual update
- Approval to apply for federal or state funding for SBHP projects
- Requests for Metro to program SBHP projects in the SCAG RTP, Metro LRTP, and SCAG TIP, as needed for compliance and eligibility to receive state and federal transportation funds

The following SBHP actions require approval by the **MROC** prior to consideration by the SBCCOG Board:

- Recommend new contracts, task orders over \$50,000 and receive and file notifications by the Executive Director for task orders under \$50,000.
- Recommend annual SBHP project list changes and Metro budget requests
- Oversee development and recommend new SBHP-related policies and procedures
- Recommend Bi-annual South Bay Highway Program Implementation Plan Updates
- Consider notifications by the Executive Director of emergency actions to initiate remedial administrative assistance for projects with unforeseen problems that need immediate attention
- Approve changes in Lead Agency that have no cost ramifications and are agreeable to all parties

The following actions require approval by the **SBCCOG Executive Director**:

- New SBHP Contracts and Task Orders with a Not-To-Exceed Value less than \$50,000
- No-net-change reallocations of contract or task order scopes and funding less than \$50,000
- Compensation and assignment of SBCCOG staff to SBHP support tasks
- Changes in lead agency that have no project cost ramifications and are agreeable to all parties
- Emergency actions to initiate remedial administrative assistance for projects with unforeseen problems that need immediate attention
- Administrative decisions regarding staff and marketing budgets, expenditures and logistics within Board-approved scopes and budgets.
- All of the above actions taken by the SBCCOG Executive Director are reported to the Measure R Oversight Committee no less frequently than quarterly.

#### RECOMMENDATION

SBCCOG Staff recommends that the SBCCOG Steering Committee receive and file this report and continue to solicit interest in this committee.

#### **BACKGROUND**

Supervisor Mike Antonovich, in one of his last actions as Chairman of the Metro Board, sent a letter to the each of the LA County Councils of Governments requesting their subregion's priority projects to be considered for inclusion in a potential sales tax measure for transportation in 2014. Supervisor Antonovich's letter, attached as Exhibit 1, asks the Councils of Governments to provide their responses to Metro by September 4, 2013.

In developing a draft, the SBCCOG staff and consultants deliberated with the Westside Council of Governments and the Gateway Cities Council of Governments to determine to see if there are shared concerns and mutually-beneficial programs and projects that could be proposed. Staff has prepared a draft response that includes broad concerns and potential projects and programs (see Exhibit 2).

#### RECOMMENDATION

The Measure R Oversight Committee recommends that the SBCCOG Board of Directors approve and transmit by September 4, 2013 the letter in Exhibit 2 responding to Metro Chairman Michael Antonovich's request for South Bay projects to be considered for inclusion in a future Los Angeles County sales tax measure.

#### Dear Chair Dubois:

In response to the June 20, 2013 letter from Immediate Past Chair Mike Antonovich, the South Bay Cities Council of Governments (SBCCOG) has discussed our concerns and potential programs /projects that we would like considered for inclusion in a potential future Los Angeles County transportation sales tax measure and the next Metro Long Range Transportation Plan and SCAG Regional Transportation Plan / Sustainable Communities Strategy. We have several overarching concerns and have attached a list of potential South Bay projects and programs.

We encourage Metro to continue the collaborative measure development process initiated by Supervisor Antonovich. We strongly believe that a successful measure requires a transparent and inclusive process that puts "Neighborhoods First" and builds from the neighborhood up to the region rather than the region-down focus of previous sales tax measures. South Bay cities are committed to developing sustainable mobility programs that address local and sub-regional congestion issues, achieve emissions reductions by dramatically growing the zero emission vehicle fleet and integrating active transportation corridors where appropriate. We understand the urgency of improving the quality of life in our suburban neighborhoods while improving the connectivity of our sub-region to the regional highway, bus and rail networks.

We believe that a first priority of a future ballot measure must be a program that delivers a geographically balanced allocation that more closely returns sales tax revenues to the sub-region of origin in proportion to the sales tax collected in the sub-region.

We also understand that a future ballot measure should ensure that Metro's current transit and highway commitments made in Proposition A, Proposition C, and Measure R are fully funded including changes in projected lifecycle operations, maintenance and rehabilitation costs related to the recently-approved Metro Acceleration Plan.

We believe that a measure that is principally used to complete prior commitments is not sufficient for success, therefore, it must also include new programs and projects which must have reasonable life-cycle cost estimates, and be highly cost effective. And, because a new local sales tax will need to be leveraged to fund even a few new priorities, a new sales tax measure must be built on sound technical justifications for projects and programs that attract investment by other public and private transportation project partners and will energize strong voter support.

At this early stage of deliberations, we need to make clear that incorporation of these initial suggestions does not constitute nor imply support for any potential sales tax measure to be developed. The SBCCOG would need to review the provisions and projects in the proposed measure to determine our position. We expect a comprehensive and collaborative development process will take more than two years to complete and do not believe a successful measure should be presented to the voters before 2016.

Realizing that this is only the first step in what appears to be a lengthy process, the SBCCOG has compiled the attached listing of programs and projects that we believe are important to South Bay voters. Thank you for this opportunity to express our initial concerns and to identify our needs. The SBCCOG looks forward to working closely with the other partners and stakeholders in any design of a new ballot measure.

#### I. OVERARCHING SBESC UPDATES

#### Metropolitan Water District (MWD) Caucus Meeting – Water Energy Nexus

The July meeting included a presentation about the closing of the San Onofre Nuclear Generating Station (Mark Martinez, SCE) and a presentation on how water agencies can assist with reducing peak demands if necessary (Jon Lambeck, MWD).

SCE has been preparing for the closure and has been increasing capacity and building up infrastructure to meet demand. Twenty two percent of the state's power is renewable from solar and wind farms but renewables are not necessarily there when energy is needed. Peak energy use does not always coincide with sunny or windy periods of the day.

The Governor's office is asking that there be more of a focus on joint messaging with water utilities – conservation, along with smart water and energy use; saving water saves energy. Water agencies are shifting energy load to off-peak times; incentivized by utilities.

#### **SCE Water Leak Detection Program Grant Award**

The proposal submitted by SBCCOG/SBESC as part of a team with WSO and Willdan has been selected for funding by SCE! Steps are underway to finalize the Scope of Work as part of the contract. The total budget is \$900,000 for two major parts and we were one of 3 successful bidders. We are expecting about \$40,000 for our administration and coordination work tasks. The bulk of the work is technical and will be performed by the sub-consultants. Up to 4 water systems in the South Bay (Lomita, Manhattan Beach, Inglewood and El Segundo) will be included in this effort to identify and repair water leaks. The optimistic goal is to request SBCCOG Board approval of the finalized contract in August.

#### **SCE Energy Leader Partnership (ELP)**

A bulletin has been drafted that will be sent quarterly to city managers and staff with important information regarding the program, cities that have moved up tier levels and next steps. SBESC staff is also planning an ELP Annual Recognition Luncheon to be held Thursday, September 26, 2013 in the Client Theatre to acknowledge the hard work of city staff, highlighting those cities that have achieved Gold & Platinum designations. Gene Rodrigues, SCE Director of Energy Efficiency and Solar, has accepted our invitation to participate in the program. In addition, meetings with the cities are being scheduled to provide a one-on-one view of the ELP program, where they stand and how their goals align with program goals.

#### **Climate Action Plans (CAP)**

Staff is working with SCE to finalize the Scope of Work and Contract for the Strategic Plan Strategies Phase 3 Funding. The Scope of Work is to develop the Energy Efficiency chapters of the Climate Actions Plans and the funding cycle ends December 2014. Staff is preparing the RFP for consulting services under this contract so that the RFP is ready to release as soon as the Contract is finalized with SCE.

The SBCCOG provided a letter of support for a regional proposal in response to the Local Coastal Program Sea Level Rise Adaptation Grant Program solicitation. The goal of this project is to develop a sea level rise and coastal storms study and is intended to support future coastal impact assessments and climate change adaptation planning work in the Los Angeles region, including along the South Bay coast. The following South Bay coastal communities are participating jurisdictions in this proposal: El Segundo, Hermosa Beach, Manhattan Beach, Redondo Beach and Torrance.

Following the resolution of these data gaps, the SBCCOG will work with South Bay Cities to schedule one-on-one training sessions between LA County and each city. LA County is providing this training due to their long term involvement with this web tool. The upcoming training sessions will be

tailored to the specific reporting needs of each city.

SUBJECT: Information Item: SCE Water Leak Detection Program Grant Award

#### **BACKGROUND**

On May 10, 2013, Southern California Edison (SCE) released the Water Leak Detection Program Request for Proposal (RFP). Water losses caused by unrepaired leaks and operating at unnecessarily high-pressure results in wasted water and wasted energy. The Water Leak Detection Program (the Program) is designed to deliver quantifiable savings for both water and energy.

SCE is implementing the Program through their Local Government Partners therefore cities in the SBCCOG are eligible to participate. Four cities in the South Bay have municipal water systems and enthusiastically agreed to be included in the SBCCOG proposal. The goal of the Program is to achieve energy savings directly, embedded or otherwise of potable (drinking) water. The role of the SBCCOG would be as a local government partner for administrative and coordination work tasks as part of a team with technical expertise in the water energy nexus.

#### **STATUS**

We are pleased to report that the proposal submitted by SBCCOG as part of a team with WSO and Willdan has been selected for funding by SCE. (The City of Westminster was the only other proposal selected in this category in the SCE territory.) Steps are underway to finalize the Scope of Work as part of the contract as well as to negotiate a final budget.

Our proposal was for approximately \$519,000 but SCE has indicated that they will be reducing all of the budgets of the successful bidders to stay within their total budget of \$900,000. We are expecting that when negotiations are completed, the SBCCOG will receive about \$40,000 for our administration and coordination work tasks. The bulk of the work is technical and will be performed by the sub-consultants – Willdan and WSO.

Up to 4 water systems in the South Bay (Lomita, Manhattan Beach, Inglewood and El Segundo) will be included in this effort to identify and repair water leaks and implement pressure management to reduce system water losses.

Staff is hoping that the contract will be finalized in time for it to go straight to the August 22, 2013 Board meeting along with an agreement to sub-contract with Willdan. Willdan will then subcontract with WSO. It is important to move this forward expeditiously since this is a short term project in which all of the work must be completed by the end of 2014.
