



Taxation of Digital Sales in the States (2012)



Lost Revenue to California From Not Applying the Sales Tax to ...

\$millions/yr	State 7.5%	Local 1%
Digital goods (books, music, games, movies and software)	\$ 130	\$ 18
Recreation and entertainment: professional sports, amusement parks, cultural events, circus / fairs, bowling alleys, video, billiards, marina services, health clubs, private club memberships.	\$ 1,920	\$ 256
Maintenance and repair: carpet and upholstery cleaning; extermination; landscaping/yard care; swimming pool maintenance / cleaning; building repair/remodeling, automobile repair; appliance repair/installation; garment/ shoe repair/alteration, laundry/dry cleaning.	\$ 2,585	\$ 345
Candy, snacks, bottled water exemption -eliminate	\$ 1,160	\$ 155
Custom computer program exemption – eliminate	\$ 375	\$ 50

"Situs Matters" Where Does the Sale Take Place in Remote Sales?

- What is the location of the sales transaction (the situs)?
- ☐ Seller's location? Location of product receipt? Product location?
- ☐ California currently uses "origin sourcing," the situs is the retailer's place of business where negotiations take place.
- Origin sourcing often => concentration of tax revenue
- ☐ far in excess of service costs at the office or warehouse location
- □ economic activity, service impacts also occur elsewhere (i.e., where product is used)




Some Remedies for Our Sales Tax Sickness

1. Apply sales and use tax to

- ☐ digital goods
- ☐ recreation/entertainment
- ☐ maintenance & repair

- □ candy, snack, bottled water
- □ custom computer programs
- → Option: Offset tax broadening with rate reduction or personal income tax credit or deduction
- 2. Eliminate or strictly limit new rebate agreements SB 533
- 3. Redefine sourcing rules to destination (receipt) \$1B GF
- 4. Reduce the county pools, send use tax pool revenues to jurisdiction of destination (receipt)


