- O. Update on South Bay Environmental Services Center Activities attached 1:45 PM
  - new CivicSparks Fellow started Talia Perluss. She will be working on: 1) EE implement equipment inventory (potentially working with volunteers), city recognition program, energy waste nexus, adding water and waste to Energy Star Portfolio manager tool
  - Public Power-Up (EV charging infrastructure) Carson, Hawthorne, and Gardena have projects and likely install Q1 2023
  - El Segundo community joint presentation Energy Efficiency and Water Conservation hybrid and recorded 39 views
  - West Basin Rain Barrel event on Sept. 24 went well 300 barrels were given away. There are almost 1000 barrels reserved by community members for upcoming events.
  - Prop 1, Round 2 Scoring 5 projects (clean water supply) were submitted for scoring for a total of \$8.810 million. 2 projects are in DAC communities. All were good projects wells, coastal restoration, school and park greenways; and runoff projects. There is only about \$3.185 million available. We will not know which projects will receive funding until next year; however, the Greater Los Angeles County IRWP approved \$900K Healthy Pocket Parks and Schools, 52nd Street Elementary project to advance for funding consideration.
