- K. Status of South Bay Regional Housing Trust 1:00 PM
  - Letters to the Governor needed as of 9/6/22, Carson, Hermosa Beach & Inglewood & SCAG received
  - Assuming the Governor signs the legislation, staff will report back in October with next steps
- L. South Bay Fiber Network 1:05 PM
  - LATA Grant application was for \$498,949
    - Scope includes Market/Needs Assessment in SB DAC/Equity challenged communities with technical overlays to propose last-mile connections that would tie back into the SBFN's middle-mile network
    - Partner cities include: Carson, Gardena, Hawthorne, Inglewood, Lawndale
    - 14 Letters of Partnership/Support were received by the SBCCOG in support of the application
    - Proposal officially received by the CPUC review team on 8/23.
  - Work Order #5:
    - Lateral connection to Torrance Transit Center on pace for service delivery in December
  - Programing for Work Order #6:
    - Review and assessment of proposed/desired lateral site connections or network improvements for a final Work Order that would program the balance of the original Metro Funding Agreement for the SBFN continues. Site possibilities include:
      - 1 LA County IEN transport circuit from Alhambra to Hawthorne location
      - 4 City of Hawthorne locations
      - 2 City of Manhattan Beach locations (including a new fire station)
      - 1 Park Location in RPV
      - Network Improvements to provide 24/7 access at "regen" locations:
      - Carson
      - Gardena
  - Wireless Pilot Project
    - SBCCOG continues its work to facilitate the implementation of Tekwerk's 2 site locations (Carson and Torrance Airport) for service to underserved businesses
    - Anticipated equipment installation and formal marketing is behind schedule
    - Both cities continue to be excited and engaged to get the pilot project up and running. That said, both cities, along with Tekwerks and ADF, are working through issues so that the project will have "every opportunity for success".
  - Application Developments
    - SBCCOG continues to meet one on one with SB cities to assess IT developments and applications that might (or are) a result of SBFN subscription. These include:
      - Off-site back-up (at Equinix or Evoque) for off-site data storage
      - New circuits for intra-city IT resiliency
      - Continued support for remote work
      - Continued support for hybrid public meetings
      - Consideration of how to support traffic sync projects/upgrades

  - First 500 survey takers get a \$10 gift card (at no cost to COG) THANK

- Survey outreach: Jonathan sent infographic and recommended caption to all cities asking they advertise ADU Survey on social media, newsletter, city website
- Consultant has completed 7 of 8 city interviews for Housing Policy comparison, final interview being scheduled with Redondo Beach
- ADU Acceleration project featured in:

## <u>Commercial Redevelopment</u> (Studio 111/Kosmont)

- Consultant is developing Feasibility Criteria to identify underperforming commercial segments in 6 participating cities
  - Preliminary locations mapped in each city
  - Consultant working on aligning potential redevelopment areas with SBFN and LTN (SBCCOG provided the GIS data)
- Consultant wants to meet with each city to discuss findings and narrow down site options
  - Jonathan is contacting Community Development Directors (CDDs) to schedule virtual meetings with consultant

## **Housing Education**

- Advisory Committee update
  - o Community members concluded their service on committee in August
- Jonathan sent draft 10-unit curriculum to CDDs for comments and discussion at 9/15 CDD meeting
  - We need all CDDs to review and send Jonathan comments before 9/15 CDD meeting

### Status of REAP 2.0

- Got clarification from SCAG that SBCCOG will be following the Subregional Partnership 2.0 guidelines for REAP 2.0, just approved Sept 1<sup>st</sup> at Regional Council
- SBCCOG is expected to do outreach to our cities to develop project proposals for REAP 2.0 application

- SBCCOG can be reimbursed for staff time doing outreach to our cities per approved guidelines
- SBCCOG Subregional Partnership 2.0 application is due February 10, 2023
  - Caveat: this application date is pending state review of SCAG's guidelines. It could be pushed back further
- Potential project: From prelim SCAG review, the South Bay Regional Housing Trust project would align with REAP 2.0 goals for funding
