Water Conservation

West Basin Municipal Water District Programs (West Basin)

SBCCOG and West Basin staff met on September 5 and September 18 to discuss implementation of programs and develop the next program cycle scope of work.

Green Business

CAGBN – The SBCCOG is working with the cities of El Segundo, Hawthorne, and Torrance to "green" certify local businesses and conduct business walks to schedule audits and help identify opportunities for sustainable improvements as well as connect business owners with utility incentives and programs. On September 20th, a news segment was filmed interviewing green businesses by the City of El Segundo that will be broadcast in October 2023. In addition, the city is working with SBCCOG to line up business interviews.

Total per city: El Segundo (17) Hawthorne (18) and Torrance (13).

South Bay Green Business Assist Program (GBAP): Ongoing

SBCCOG continues to provide information to local businesses on opportunities to implement sustainability programs. In addition, businesses receive information on the status of SBCCOG utility partners' programs. GBAP by city: Carson (18), El Segundo (52), Gardena (26), Hermosa Beach (12), Hawthorne (77), Inglewood (20), Lawndale (30), Lennox (10), Lomita (9), Manhattan Beach (10), Palos Verdes Estates (9), Rancho Palos Verdes (11), Redondo Beach (6), Rolling Hills Estates (6), Torrance (84) and Los Angeles County – Community of Westmont (1) for a total of <u>381</u> businesses in the program as of September 2023.

Climate Action

A new CivicSpark Fellow is completing the GHG emissions inventories. Currently, the Fellow is reviewing relevant work: transition reports, Climate Action Plans for the South Bay region, and the ICLEI user manual. The Fellow also started reviewing the GHG inventory data and assessing what is needed to complete reports for the rest of the South Bay cities.

Energy Efficiency

<u>Regional Energy Network (SoCalREN) CITY SUPPORT</u> Contract period is January 1, 2023 - December 31, 2023 Contract goal: Work Plan (including goals) are underway for 2023.

Facility Equipment Inventory Pilot Project – SBCCOG staff and the Civic Spark Fellow conducted onsite visits to collect equipment information which will be used to identify energy efficiency projects. The team is working to complete all city halls by December 2023.

To date, SBCCOG has inventoried 37 facilities across 12 South Bay facilities. Through this process, staff has also completed lighting recommendations for 20 facilities, finding over 500,000 potential kWh savings from lighting retrofits. SBCCOG has also identified more than 50 HVAC units that contain banned or phased out refrigerants (R-22 and R-410a). These refrigerants have been banned/phased out due to their ozone depletion and global warming potential.

South Bay Energy & Climate Public Agency Recognition Program –recognizes SoCalRENenrolled cities for their efforts in pursuing energy efficiency initiatives and sustainability related tasks (activities must be completed by the third Monday of November annually). To date, 2 cities have reached the Gold recognition level, 3 cities have reached the Silver level, and 4 cities have reached the Bronze level. SBCCOG staff continues to monitor cities' completed activities and sends city staff quarterly progress reports. Cities' accomplishments will be recognized at a Recognition Ceremony, scheduled for <u>December 6th</u>, 2023.

Regional Energy Network (SoCalREN) MULTIFAMILY & KITS FOR KIDS Contract period is January 1, 2023 – August 31, 2024 Contract goals: Contact, track progress, and outreach to local community organizations; track number of virtual events held and attendees; distribute program collateral to local community organizations

Multifamily

The SBCCOG and ICF together continue to develop new strategies focused on outreach directly with contractors. ICF has received a database of multi-unit residential building property managers which they are reviewing to identify eligible properties in our geographic area. ICF was also able to send an email to all South Bay contractors, using their contractor network. The SBCCOG continues to share program information with eligible properties. The SBCCOG is currently working with the City of Lomita to explore the possibility of enrolling Lomita Manor, a low-income senior multifamily property, in the program.

Kits for Kids

The SoCalREN's Kits for Kids program focuses on providing energy efficiency education to third and fourth grade students. <u>Activities for the 2023-24 program year</u>: 3 South Bay schools have already signed up; 1 classroom from Towne Avenue in Carson, 5 classrooms from 135th Avenue in Gardena, and 2 classrooms from Zela Davis in Hawthorne. In the 2022-2023 program year, 10 classrooms participated in the program: 1 classroom from 135th Street School in Gardena, 3 classrooms from Zela Davis in Hawthorne, and 6 classrooms from Washington Elementary in Redondo Beach.

Mid-Fall of 2023, the SBCCOG will begin outreach to South Bay Schools Boards and work to increase SoCalREN enrollment. The SBCCOG plans to discuss relevant SoCalREN Project Delivery Programs, Kits for Kids, Turf Replacement Programs, Water Bottle Filling Stations, and other programs offered by SBCCOG Partners.

Transportation

<u>Metro Express Lanes (MEL) (Contract period November 18, 2022 – November 17, 2023)</u> South Bay events are being held both virtually and in-person. SBCCOG staff continue to prepare, update, and share the SBCCOG outreach calendar for events that provide opportunities to support the mission and goals of the Metro Express Lane program. In total, the SBCCOG/SBESC distributed MEL materials at 14 events. SBCCOG staff has begun working with Metro on a contract renewal for November 2023-2024.
