- RONSON CURRENTLY REVIEWING WITH LEGAL COUNSEL THE DRAFT LACAHSA MOU. \$11M IN NEW FUNDING THROUGH MEASURE A. PPO = PRODUCTION AND PRESERVATION AND THAT IS ABOUT \$5.4M OF THE TOTAL. RPHP = RENTER PROTECTIONS AND PREVENTION. THIS FUNDING WILL HELP PROVIDE LEGAL SERVICES AND LEGAL INTERVENTIONS TO PROTECT RENTERS. COULD INCLUDE EVICTION DEFENSE, CRIMINAL RECORD CLEARING, ETC. - RONSON WE DON'T HAVE A PIPELINE OF PROJECTS LIKE SAN GABRIEL VALLEY DOES FOR THEIR HOUSING FUNDS (THROUGH THEIR TRUST) SO WE HAVE TO FIGURE OUT WHAT TO DO WITH THAT \$5M.
- RONSON THE HOUSING BUILT HAS TO BE PERMANENT. THINKING OF ISSUING AN RFP OR WORKING WITH CITIES TO IDENTIFY PROJECTS THAT MAY BENEFIT FROM IT.
- RONSON THE ADDITIONAL FUNDING AND PROGRAMS WILL REQUIRE ADDITIONAL STAFFING AT SBCCOG. WILL BE LOOKING TO REORGANIZE THE HOMELESS SERVICES TEAM AND ADD STAFF: ADMIN STAFF TO SUPPORT CONTRACTS; DATA ANALYST TO ASSIST WITH REPORTING; HOUSING SPECIALST; HOUSING LOCATOR. THE HOMELESS SERVICES TEAM WOULD INCLUDE ADDY, A PROGRAM COORDINATOR, AND CARE COORDINATOR (CATHY).

 - JAKE RFP WAS RELEASED IN APRIL. 8 PROPOSALS RECEIVED, 3 WERE SELECTED FOR INTERVIEW. THE REVIEW COMMITTEE IS RECOMMENDING STUDIO ONE ELEVEN. THEY WORKED ON THE FIRST PHASE OF THE PROJECT IN REAP 1.0 AND HAVE A STRONG BACKGROUND IN SOUTH BAY SPECIFICS.
 - UPHOFF THIS IS JUST FOR COMMERCIAL REDEVELOPMENT? JAKE YES, BUILDING UPON THE REAP 1.0 PROJECT, THIS IS A DEEPER ANALYSIS WITH A FIT AND FEASIBILITY STUDY. NOT EXPLORING SITES, BUT DEEPER DIVE INTO THOSE SITES ALREADY IDENTIFIED.
 - UPHOFF SO RESULTS OF THE PROJECT SHOULD BE ABLE TO BE APPLIED TO OTHER CITIES TOO? JAKE – YES, EXACTLY.
 - HUFF WHAT IS KOSMONT'S AFFILIATION? JAKE THEY WILL DO THE ECONOMIC/FIT AND FEASIBILITY ANALYSIS AS A SUBCONSULTANT TO STUDIO ONE ELEVEN.

KIM – USUALLY DO ABOUT 100 COMMUNITY EVENTS IN A YEAR, HIT THAT NUMBER IN APRIL. VOLUNTEER TRIP TO THE SANITATION DISTRICTS SAN JOSE CREEK WATER RECLAMATION PLANT.

KIM – ABLE TO GET CALIFORNIA GREEN BUSINESS NETWORK CERTIFICATION FOR THE ENTIRE SUBREGION BEING PAID FOR BY COUNTY FOR 1 YEAR. KITS FOR KIDS EXPANDED BY 300% ALLOWING MORE SCHOOL DISTRICTS TO PARTICIPATE. FIRST REGIONAL PARTNER TO PILOT A COMMERCIAL DIRECT INSTALL PROGRAM.

KIM – DISTRIBUTED 5 GHG REPORTS TO CARSON, GARDENA, HERMOSA BEACH, INGLEWOOD AND TORRANCE. REPORT LOOKS AT HOW EMISSIONS HAVE REDUCED SINCE PLANS WERE ADOPTED. 4 RESILIENCE HUBS ANALYSES TO GARDENA, HAWTHORNE, LAWNDALE, AND MANHATTAN BEACH. LOOKED AT CITY FACILITIES THAT COULD BE USED FOR RESILIENCE CENTERS AND WHAT MORE MIGHT NEED TO BE

DONE TO THEM TO MAKE THEM BETTER. COMPLETED AND SUBMITTED 10 CITY AB 802 COMPLIANCE RPEORTS FOR CITIES.

UPHOFF - WOULD YOU PRODUCE SPECS ON RESILIENCY CENTERS? KIM - THIS WORK IS MORE ABOUT ENERGY EFFICIENCY AND POTENTIAL UPGRADES LIKE SOLAR AND EV CHARGING. IT WOULD BE LIKE SITE LOCATION AND TO GIVE CITIES AN IDEA OF THE TOOLS TO TAKE IT TO THE NEXT STEP. UPHOFF - SUBREGIONAL COORDINATION OR MAPS TO REFER PEOPLE THROUGHOUT THE SOUTH BAY WOULD BE SOMETHING TO EXPLORE.

KIM - CIVIC SPARK FELLOWS WERE FURLOUGHED WITHIN ABOUT A 24 HOUR PERIOD, BUT WE BROUGHT THEM ON AS TEMPORARY STAFF SO THEY COULD CONTINUE THEIR WORK. FEDERAL FUNDING RECISIONS WERE THE CAUSE. FUNDING ISSUES COULD ALSO IMPACT BENCHMARKING WORK. ENERGY STAR PORTFOLIO MANAGER IS FUNDED FEDERALLY. WHEN FED BUDGET WASN'T ABLE TO BE APPROVED A FEW YEARS AGO, THEY CLOSED DOWN THE WHOLE TOOL AND IT COULDN'T ACCESSED. STATE BENCHMARKING LAW MAY BE IMPACTED. WE DOWNLOADED DATA SO WE HAVE THE HISTORIC INFO IN CASE IT IS AFFECTED AGAIN.

KIM - GREEN BUSINESS PROGRAM. PIECED DIFFERENT PROGRAMS TOGETHER TO FUND THE SOUTH BAY GREEN BUSINESS ASSIST PROGRAM. OVER 400 BUSINESS PARTICIPATE TODAY. USE IT TO LEVERAGE OTHER PROGRAMS AND DISTRIBUTE INFO TO THAT AUDIENCE. CERTIFICATION WILL BE TIED TO THE PROGRAM BUT WE ALSO HAVE SPONSORS FOR THE PROGRAM (WEST BASIN, GOLDEN STATE WATER). APPROACHED BY GBN TO IMPLEMENT A SCE PROGRAM FOR DISADVANTAGED OR HARD TO REACH BUSINESSES. CONTRACT TO ENGAGE BUSINESSES AND LET THEM KNOW ABOUT THE PROGRAM AND GET THEM ENROLLED. THIS TYPE OF CONTRACT IS DIFFERENT. IT'S MORE LIKE A "PAY FOR PERFORMANCE" BUT THE WAY THIS ONE IS SET UP, WE GET HALF THE FUNDING RIGHT AWAY AFTER STAFF GOES THROUGH THE TRAINING. WE DON'T THINK WE WILL HAVE A PROBLEM TO ENROLL BUSINESSES, \$300/BUSINESS LIMIT OF \$20K.

ELEANOR - COOL ROOFS FEASIBILITY STUDY RFP CONSULTANT RECOMMENDATION. UP TO 15 SITES TO BE CHOSEN, AND BASED ON THOSE LOCATIONS, COSTS AND FUNDING AND DETAILS WOULD BE DEVELOPED. 2 PROPOSALS RECEIVED, SELECTION COMMITTEE INTERVIEWED BOTH.

KIM – \$11M RONSON SPOKE ABOUT EARLIER IS NOT IN THE DRAFT BUDGET. IF THE MOU AND DETAILS ARE FINALIZED IN TIME TO INCORPORATE IT BEFORE THE JUNE MEETING, IT WILL BE. IF NOT, IT WILL COME BACK AS AN AMENDMENT TO THE BUDGET IN A FUTURE MEETING.

LARA – DRAFT BUDGET IS BALANCED. INCREASES TO REVENUE LARGELY FROM SCAG/METRO REAP 2.0, CALTRANS CARSON TO THE SEA GRANT, COOL ROOFS STUDY, AND LA COUNTY REN AND DECARBONIZATION/DIRECT INSTALL. INCREASES TO EXPENDITURES ARE PRIMARILY THE INCREASED STAFFING NEEDS FOR THE NEW GRANTS AS WELL AS THE NEW OFFICE RENT. AUDIT FEES ARE EXPECTED TO INCREASE AS WELL.

KIM – ALSO PROPOSING TWO POLICY UPDATES. ONE INCREASES THE RESTRICTED RESERVE COMMITMENT FROM \$347K TO \$649K AND IS BASED OFF OF AN ESTIMATED 3 MONTHS OF FY25-26 OPERATIONAL EXPENSES. DUE TO SIGNIFICANT OPERATIONS CHANGES WITH THE OFFICE MOVE, STAFF FELT IT WAS PRUDENT TO CHANGE THE GOAL FROM THE FY22-23 BASIS IT WAS ESTABLISHED ON. THERE IS ADEQUATE FUNDING AVAILABLE TO COVER THIS INCREASE. SECOND POLICY UPDATE IS A SALARY SCHEDULE INCREASE TO GO INTO EFFECT JANUARY 1, 2026. AS MINIMUM WAGE INCREASES FOR HOURLY WORKERS, THERE IS AN IMPACT ON SALARIED WORKERS TOO SINCE THEY HAVE TO MAKE DOUBLE THE HOURLY. OVER THE YEARS, ENTRY LEVEL POSITIONS WERE STARTING TO GET LOST. ADJUSTMENTS WERE MADE TO THOSE IMPACTED, BUT NOW IT IS IMPACTING THE OTHER POSITIONS SINCE THE ENTRY LEVEL SALARY RANGES HAVE CREPT UP. WOULD LIKE TO INCREASE IT ANNUALLY GOING FORWARD BASED ON ANTICIPATED STATE MINIMUM WAGES. DOESN'T MEAN POSITIONS ARE BEING PAID THIS, BUT IT GIVES THE FLEXIBILITY TO ALLOW FOR STAFF TO STAY WITHIN THEIR POSITIONS AND RECEIVE INCREASES WITHOUT BEING PUSHED INTO A NEW POSITION.

UPHOFF - I THINK THE RESERVE UPDATE IS PRUDENT.

MONTEIRO - SALARY SCHEDULE CHANGES MAKE SENSE.

QUINN – ANY CONTRACT EMPLOYEES AND PROVISIONS TO THAT COMPENSATION? KIM – WALLY IS A CONTRACTOR, MIKE BOHLKE, JON RODMAN. THOSE ARE PRIMARILY BASED ON GRANT WORK, SO THERE ISN'T AN ANTICIPATED IMPACT.

HUFF – I SEE A SENIOR PROGRAM MANAGER BUT DON'T SEE PROGRAM MANAGERS. KIM – SALARY SCHEDULE IS ALL OF THE POSITIONS WE HAVE, BUT THEY ARE NOT NECESSARILY ALL FILLED.

QUINN – ARE CITY DUES GOING UP OR DOWN? LARA – IN FEBRUARY 2024, BOARD APPROVED A CPI BASED INCREASE EACH YEAR WHICH IS INCLUDED IN THE BUDGET.
