1. Regional Collaboration & Expertise


A joint effort that creates economies of scale and shared expertise—helping cities meet their affordable housing goals.

2. Demand

Enormous and especially among essential workers in the region.

3. Reliable, Ongoing Funding

Backed by a recurring, long-term grant source with no end date—giving sustained access to housing funds.

HOUSING NEEDS ASSESSMENT

- Displacement Is Rising Longtime residents and essential workers are being priced out of the region.
- Affordable Housing Gap The region needs 34,179 additional homes to meet state housing targets.
- Rent Is a Burden More than half of renters pay over 30% of their income on housing.
- Long Commutes Add Strain Over 54,000 workers commute into the South Bay each day.




WHAT IS A HOUSING TRUST?

Funding source to finance the preservation and production of affordable housing.

Established by state, city, or county gov'ts as a Joint Powers Authority OR by a non-profit 501c3

Funding sources include government, bond/tax measures, private donations, and philanthropy.



WHAT ARE THE BENEFITS?

- 1. <u>Direct Project Funding:</u> Provides gap funding for the development of affordable housing for current community residents.
- Additional Project Funding: Increases competitiveness of affordable housing projects for additional local, state, or federal funding.
- 3. <u>More Funding:</u> Improves Trust grant applications for regional, state, and federal funding by supporting a collaborative regional approach.
- 4. <u>Staff Relief:</u> Offers technical assistance and expertise in housing compliance, reporting, and program design—reducing city staff burden.
- 5. RHNA Credit: Contributes affordable units toward a city's Regional Housing Needs Assessment (RHNA) requirements.
- 6. <u>Expanded Partnerships:</u> Builds partnerships with other public, private, and nonprofit entities engaged in affordable housing.

WHAT PROGRAMS CAN A TRUST CONSIDER?

LACAHSA & MEASURE A

Los Angeles County Affordable Housing Solutions Agency: a regional organization to "make housing more affordable, help people stay in their homes, and increase housing options for people experiencing homelessness."

Sept 2022 SB 679 LACAHSA

May 2023 LACAHSA Board held its first meeting.

Nov 2024 Measure A – passed, providing a recurring revenue source (sales tax revenue)

Aug 2025 – Ist tranche of funding disbursed
