O. Land Use and Transportation Update & REAP

- Housing Trust Feasibility Study
  - OPTION IS TO FORM THE ORGANIZATION AS A SHELL ESSENTIALLY BUT HOLD BACK ON HIRING AND ROLLING OUT PROGRAMS UNTIL THE INITIAL MEASURE A HOUSING CALL IS COMPLETED. THAT WILL REDUCE ADMINISTRATIVE COSTS TO VERY MINIMAL.
- Commercial Redevelopment
  - O ROMOFF MEETING WITH FINAL PARTICIPATING CITY IS BEING SCHEDULED. CITY GETS TO PICK SITES THAT ARE ANALYZED. A SUBREGION-WIDE UNDERUTILIZED SITE MAP IS BEING DEVELOPED. AFTER ALL MEETINGS WITH PARTICIPATING AGENCIES ARE COMPLETED, A FIT AND FEASIBILITY ANALYSIS WILL BE CONDUCTED FOR THOSE SITES.

  - ROMOFF MOBILITY HUBS PROJECT KICKS OFF ON WEDNESDAY WITH FEHR & PEERS WHO THE BOARD SELECTED AS THE CONSULTANT.

RESIDENTIAL DIRECT INSTALL STARTING WHICH INCLUDES GAS STOVE AND WATER HEATER REPLACEMENTS FOR ELECTRIC UNITS. ONLY TARGETING SELECTED AREAS RIGHT NOW. CEC IS HAVING THEM FOCUS ON VERY FAST-START LOCATIONS. INCLUDED MOBILE HOMES AFTER OUR ADVOCACY.

THE COUNTY HAS ASKED SBCCOG IF WE WOULD LIKE TO BE THE MAIN CONTACT FOR RESIDENTS HELPING THEM THROUGH THE PROGRAM PROCESS FOR AN ADDITIONAL AMOUNT OF \$200K/YR FOR THE NEXT THREE YEARS. TAKING ON THIS ADDITIONAL WORK WOULD REQUIRE MORE TECHNICAL SUPPORT AND STAFF THAN THE SBCCOG CURRENTLY HAS.

QUINN - HAVE YOU BEEN IN TOUCH WITH CITY MANAGERS ABOUT THE FACILITIES?

FUENTES – IT HAS NOT BEEN AN ISSUE OF CITIES BEING UNRESPONSIVE, CITY STAFF HAS BEEN GOOD. WHAT WE ARE FINDING IS THAT THERE ISN'T A LOT OF INCENTIVE FUNDING AVAILABLE FOR HVAC PROJECTS RIGHT NOW. ONE THING THAT THE REN IS DOING IS WORKING WITH TRADE PARTNERS TO IDENTIFY TECHNOLOGIES THAT CAN BE ADDED TO EXISTING EQUIPMENT TO MAKE IT MORE EFFICIENT. WE ARE LOOKING AT DOING A VENDOR FAIR TO CONNECT CITIES WITH VENDORS.

STAFF IS EXPLORING TWO COMPANIES WHO ARE INTERSTED IN TAKING OVER AS THE INTERNET SERVICE PROVIDER. BOTH HAVE COMMITTED TO WORKING TO EXPAND THE NETWORK. MORE RESEARCH IS BEING DONE AND WILL BE PRESENTED TO THE BOARD IN THE FUTURE.

HUFF – HOW DO YOU GET THE WORD OUT FOR THESE PROGRAMS? CHU – THERE IS FUNDING IN MEASURE A FOR PROMOTION.

HIGHLIGHT THINGS THAT ARE HAPPENING IN EACH CITY

T. Update on the Local Travel Network & E-Bike Safety Issues

TSAI: NO MAJOR LTN UPDATES THIS MONTH. THE CONSULTANT TEAM WORKING ON THE CARSON TO THE SEA PROJECT IS CONDUCTING A GAP ANALYSIS WITH RECOMMENDATIONS EXPECTED NEXT YEAR. METRO IS ACCEPTING APPLICATIONS FOR THE OPEN STREETS GRANT THAT WOULD SUPPORT EVENTS FOR THE WORLD CUP AND OLYMPICS. SBCCOG CAN TRY TO COORDINATE IF THERE ARE MULTIPLE CITIES CONSIDERING AN APPLICATION. THERE IS A 30% MATCH REQUIRED.

OBAGI – TOOK KIDS ALONG MANHATTAN BEACH BOULEVARD OVER THE WEEKEND ON BIKES. THERE ARE GOOD MARKED BIKE LANES IN REDONDO BEACH BUT ONCE YOU GET INTO THE MANHATTAN BEACH AREA, THEY ARE NON-EXISTENT AND SIMILARLY IN TORRANCE, THERE ARE DISJOINTED SECTIONS OF BIKE LANES. CITIES NEED TO WORK TOGETHER BETTER ON THESE PROJECTS.

TARNAY: WE DEFINITELY WANT TO START WORKING TOGETHER ON THIS. WOULD LOVE TO SEE MORE MULTI-JURISDICTIONAL PROJECTS.

JACKSON: PROPS TO REDONDO BEACH FOR THEIR BIKE PROJECTS.

DIERINGER: IS THERE A BIG MAP OF THE LTN?

SIEMBAB – YES, BUT THE PROJECT IS MORPHING INTO A MORE DIFFUSE PROJECT OF ZONES AND NOT SPECIFICALLY LANES.

SUAREZ: IT'S ALSO IMPORTANT TO IDENTIFY WHERE PEOPLE ARE GOING.
